Continuing need for more full-time instructors 2014-2015



Description: The need to add two more full-time instructors is greater than ever. With one of the goals to provide a full offering of all of the courses at the Palmdale campus and to meet the state mandated ratio of full-time instructors to adjunct instructors, the college should be looking to add four full-time instructors. The Palmdale campus needs onsite, Full-time Instructors to help provide the administrative support to the Chair and Dean. The two full-time instructors at the Lancaster are helping meet the administrative needs currently, but with anticipated growth of the program, this will be too little. The Palm campus needs two full-time instructors and a full offering of the courses so that any student could study at either campus exclusively and still receive an associates degree or an associates transfer degree. Also a student from either campus should be able to start at one campus and complete their degree at the other campus, without interruption. Description: Both of these courses require expendable materials to be used each semester the courses are offered. Currently these courses are very popular and they are offered each semester. The AJ205 course, Criminal Investigation, is offered five times each semester and the course requires the students to investigate a crime scene. Each of these crime scenes uses pieces of evidence (Dummies, expended shell casings, fake blood, fingerprint materials, etc). The AJ208 course, Introduction to Forensic Science, is offered twice each semester and the course requires the students to investigate a crime scene and to learn to use the common equipment that law enforcement personnel would use to facilitate the

collection, preservation and comparison of evidence. These materials would include Fingerprint cards, fingerprint powder, photographic equipment, lasers, property bags, latex gloves, etc. (Final) [Preview Formatting]
