# a. Tina McDermott - Accreditation Report

Ms. Tina McDermott addressed the members regarding progress on accreditation reports. Ms. McDermott discussed the completion and submission of the Student Learning Opportunities (SLO) Proficiency Report, the relationship of SLOs to Accreditation, and the importance of cross-campus dialogue. In addition, Ms. McDermott addressed the following topics:

- o Set-up of Midterm Standard Committees
- o Progress of Midterm Report Mid-January Deadline for Committees
- Updates on Integrating Planning issues Program Review Updates Online, Review of Budgeting Processes

Ms. McDermott stated the committees are doing well. She reiterated the importance of 100% of all data being maintained in WEAVE, in order to create reports to review and share. Action plans and minutes must be documented and in WEAVE as well, to be used as evidence in reports. Ms. McDermott explained the importance of results being transparent and easily accessible for documentation and communication. A goal is using SLOs (all Os) in our planning and budgeting processes.

### b. Dr. Fredy Aviles – Student Learning Outcomes Report

Dr. Fredy Aviles addressed members giving the following report regarding Student Learning Outcomes:

As of November 1st, 2012 the SLO committee has accomplished the following:

- Completed the ACCJC SLO status report with help of Tina McDermott, Aaron Volcker, and VP of
  academic Affairs Sharon Lowry: 100% of course SLOs have been written, 92% have ongoing assessment
  and action plans, 80% of PLOs have been written and 47% have ongoing assessment and action plans,
  about 80% of OOs have been written and are being assessed.
- Held flex events: SLOs/PLOs: Action Plans Programs & Budgets on September 27 and SLOs/PLOs: Closing the Loop on November 1<sup>st</sup>. Both were poorly attended but had lively discussion.
- Reviewed and approved SLOs for new courses: ART 130, ART 132, HIST 120, KIN 181, KIN 182, Math 065, Math 124, Math 148, Engr 125, Engr 215, Engr 225, Bio 201, Bio 205, Hist Geol 102, HD 102
- Approved the following course revisions: PSY 234, PSY 201, RADT 101, RADT 102, RADT 103, RADT 104, RADT 106, RADT 107, RADT 108, RADT 109, RADT 201, RADT 202, RADT 203, RADT 204, RADT 207, RADT 208, RADT 209, RADT 210
- Reviewed and approved PLOs: Dance, KIN, Psychology AA-T
- Had live discussion about Operational Outcomes (OOs) with guidance from the VP of academic affairs. It
  became apparent that the SLO committee is also responsible for OOs. The committee is currently
  discussing the procedure for their approval and review.
- We are having ongoing discussion about: the SLO/PLO revision process, Operational Outcomes, assessment of General Education Outcomes (GEOs), assessment of the SLO committee procedures
- Note about transfer degree PLOs: one has been approved, 5 are in progress. The last SLO committee meeting of the fall 2012 semester will be held on November 26, 2012. It is urged that all remaining PLOs be submitted no later than the Wednesday morning of November 21<sup>st</sup> to be included in the agenda.
