Ms. Maria Clinton called the meeting to order at 3:07 p.m. Ms. Clinton informed everyone that Ms. Charlie will be out for this semester on personal leave and she will be picking up her cochair role for this committee earlier than expected. Ms. Clinton let everyone know that constructive criticism is welcome as she learns this new role. Ms. Clinton noted that Ms. Charlie will be an e-mail away and will be working with her during this transition. Ms. Clinton welcomed and thanked everyone for coming. Ms. Drake will be representing Mrs. Lowry on the committee for today's meeting. Mr. Rick Motawakel is replacing Ms. Maria Clinton's faculty representative position for Technical Education on the committee. Dr. O'Neil will be proxy for Mr. Dexter Cummins at today's meeting. Dr. Jill Zimmerman is here to represent Dr. Marder for the GED course revision and the new GED certificates. Dean Michael Jacobs, Ms. Rose Toll, Ms. Ann Steinberg, Ms. Lisa Karlstein-Francey, Ms. Cynthia Kincaid, Mr. Terry Rezek, Mr. Robert Falb and Mr. Mark Branner were all in attendance to present their courses, certificates and degrees and/or other items of discussion for today's agenda.

#### 1. Approval of Agenda

Ms. Clinton announced that we have an amendment to the agenda. Ms. Snow has prepared a handout of this agenda amendment for the committee for the addition of ELTE 140, ELTE 220 and FTEC 123 to today's agenda. There were no comments or concerns with the agenda. It was moved and seconded to approve the agenda. The motion carried unanimously.

- 2. Approval of Minutes from December 11, 2008

  It was moved and seconded to approve the minutes from December 11, 2008. There were no comments or concerns. The motion carried unanimously.
- 3. Graduation Proficiency Reading Requirement Memo from October 23, 2008 (Action Item)
  Each division who voted from November 13 and December 11 confirmed that they were in favor of raising the
  Graduation Proficiency Reading Requirement (as described from the October 23, 2008 memo) to Eligibility for
  College Level Reading (AVC assessment) or Completion of READ 099 with a satisfactory grade of "C" or "P"
  (Pass). Today, both VAPA and Language Arts also reported that yes, they are in favor of raising the Graduation
  Proficiency Reading Requirement as described above. The overall consensus is in favor of this requested action.
  It was moved and seconded to approve raising the Graduation Proficiency Reading requirement as proposed above.
  The motion carried unanimously.
- 4. Syllabus Guidelines Action Item (need input from Instructional Resources and Language Arts)
  The committee needs to decide on new guidelines for how much time an instructor has to give a syllabus to their students. This new action will be reflected in Board Policy, "Guidelines for Creating an Effective Syllabus", and in tenure review paperwork.

(This vote was subsequently changed / corrected: See Minutes from 2/26/09.) (This item comes back today for input from Instructional Resources and Language Arts for this issue. The three options are  $1^{st}$  class meeting,  $2^{nd}$  class meeting, and  $2^{nd}$  week. Instructional Resources voted  $2^{nd}$  class meeting and

Language Arts voted to leave it alone at two weeks. The consensus is that most divisions voted for the 2<sup>nd</sup> class meeting. It was moved and seconded to approve this vote. The motion carried unanimously.)

5. Catalog Rights Policy – Memo (Suggestion from Counseling) (Motion to Approve)
Dr. Coleman-Carew presented their recommended language change of the Catalog Rights Policy in the current college catalog in order to clarify and create fairness. The counseling division pointed out that the current language "creates disparate treatment of students, based upon the first term they don't attend school. A student who first misses a semester in Fall can be out for two full semesters and maintain their catalog rights, whereas a student who first misses in Spring can only be out for one semester to retain their catalog rights." Counseling recommends removing the statement "Continuous attendance is defined as attendance in at least one regular semester (fall or spring) in each calendar year." Replace the aforementioned sentence with, "A student will lose catalog rights if there is no course notation on the transcript for two consecutive, regular (fall/spring) semesters." The committee asked that "course notation" be further clarified for the students. This will come back next meeting for action.
