		Herman	2. Susie Herman gave a status report on CPR/AED and First Aid Classes being offered. In January 2019, 40 people were trained in CPR/AED and 37 people were trained in First Aid. Two more training dates are scheduled in February. On February 26, there are 30 spots offered for First Aid Training and on February 27, there are 30 spots offered for CPR/First Aid Training. Any

		instructor taking the courses will receive 4 hours of Standard 3 Credit for each course taken.
	Jared Simmons	3. Jared gave a status on the lighting in the Library Plaza and water overspray by sprinklers on the northeast side of the BE building. The water that is used for irrigation on the campus has been turned off for the last two months for winter. A request was entered into the FS Work Request System to correct the sprinkler overspray and that work order was completed, but there has not been an opportunity to date to check the overspray, due to the water being turned off. We will revisit this matter during the next meeting scheduled in April 2019 as the water will be turned back on to the irrigation systems by that time. As to the lighting on the platform in the Library Plaza – the lighting there has not worked for years and is disconnected and will not be repaired. All other walkway lights are working in surrounding areas.
V. New Business	Terry Cleveland	Issues Discussed: 1. Review of the following by Terry Cleveland: a. Work related accidents reported since the last Safety Committee Meeting on November 28, 2018: 0 first aid cases; 2 medical cases; 0 lost time cases; Total of 2 cases. Terry Cleveland reported on all new accidents in detail at the meeting. b. Year-to-date work related accident statistics (calendar year 2019): 0 first aid cases; 1 medical case; 0 lost time cases; Total of 1 case. c. Terry discussed the findings of the latest scheduled periodic Safety Inspection, which was on January 3, 2019. A copy of the report is attached to these minutes. Terry also discussed the use of space heaters and provided some criteria for using using space heaters. Jared suggested creating a Board Policy regarding the use of portable electric space heaters so all questions can be referred to Board Policy itself and if rules are then neglected, there may be a disciplinary action imposed. Terry will work on putting together language for a Board Policy concerning the use of portable electric space heaters. A motion was made by Jared with a second by Yvonne Harvey to begin the process of creating a new Board Policy.

d. Terry discussed the current year-to-date Property and

Liability Accident Log. A copy is attached.



		Terry Cleveland Jared Simmons	2. Terry gave a status report on the Emergency Drill Program for AVC. There have been no new Emergency Drills since the last Safety Committee meeting. Terry did share that during the upcoming Evacuation Drills later this month, students of Michael Hutchison's Fire Technology class along with Michael will observe the nighttime Emergency Evacuation Drill to better understand the utility shut off and alarm systems. After the drill the students will have a quick tour of the nutrition lab fire suppression system and the Sheriff's station for a look at their alarm systems. They will also tour the fire pump in lot 3 as well as a stand-pipe system. Jared Simmons and Skilled Maintenance Worker Lead Steve Epps will lead the tour. 3. Jared discussed the use of Keenan's SDS data base. He indicates he has organized Keenan's digital records into categories that correspond to each building on campus. The Keenan system uses QR codes that can be scanned to gain access to all SDS information for the campus. The SDS information on the Keenan database is generated by our annual Hazardous Materials Inventory. QR codes can also be used for a certain building or a certain room in a building, which would show their hazardous contents. The question was posed as to if there are other documents that should be stored in the Keenan database? Possibly the SPCC plan? We discussed making the QR codes more prevalent on campus. Also discussed was the possibility of each department that contains hazardous materials being responsible for updating their own SDS information rather than M&O.

The purpose of the visit was to conduct site safety inspections at all four campuses and identify potential workers' compensation hazards and/or property and liability hazards. SITE - LANCASTER MAIN CAMPUS

Location: Weight Room

The weight room is a complete improvement under the direction of Thomas Gang, Athletic Director. In prior inspections, the room revealed several safety concerns with loose or damaged floor mats, weights on the floor and poor lighting. The new weight room has new weight equipment, and the entire gym floor is cushioned and designed for an athletic environment. Weights are stacked on a rolling rack for easy access and clean up. Mr. Gang also worked closely with campus security to improve student accountability. The site should consider posting gym rules as a reminder for all occupants.




Photo 1 - New Weight Room Layout

SITE - LANCASTER MAIN CAMPUS

Location: Basketball Gym

An exposed light bulb creates a shock hazard. The site should consider covering the exposed light bulb in the supply room to prevent accidental contact with the light fixture.

Using random items as a door stop creates a trip fall hazard. The exercise block used to prop the gym door open should be replaced with a device designed as a door stop.

SITE - LANCASTER MAIN CAMPUS

Location: Baseball Dugouts

The dugout steps and walkway pose a trip fall hazard. The site should consider replacing the damaged surface material. The surface material is worn in several areas on the steps, ramp, and space in front of the bench. Most of the surface wear is on the home side due to regular use during practices. The AVC teams practice and use the space on a regular basis; however, the visitor's side has some damage near the top of stairs.

SITE - LANCASTER MAIN CAMPUS

Location: Welding

The ladder stored near the door is obstructing access to the fire extinguisher and should be relocated and secured away from a door way. Access to the fire extinguisher must remain clear.

The area around the eyewash station is obstructed with cleaning equipment. The site should consider storing the cleaning equipment in an area away from the eyewash station. Access to the eyewash station must remain free of obstacles at all times.

The practice of using miscellaneous items to hold doors open should be reconsidered. Using a dust pan to hold a door open creates a trip fall hazard. The site should consider replacing the dust pan with a customary door stop.

TE2 Room 130 and surrounding rooms in the welding department have heavy rodent activity. Rodents are linked to several zoonotic diseases which pose serious health risk to humans. The entire area smelled of rodents and sounds of rodent movement can be heard above. The site should consider aggressive methods to remove the rodents.

SITE - PALMDALE REGIONAL AIRPORT

Location: Computer Room

The window located in the computer area is broken from the outside. The window is covered with window tint; however, birds continue to fly into the glass. It is unclear if the tint is reflective due to the security restrictions around the building. Outside access is restricted to authorized military personnel.

The ceiling in the computer room has loose light fixtures and ceiling tiles. The ceiling fixtures and tiles should be secured.

SITE - PALMDALE CENTER

Location: Offices

Space heaters create a fire hazard. Space heaters create fire hazards as there is a risk for the employee to leave the device unattended. The device may overheat or damage cords located under the employee's desk. The site had several offices with space heaters. The site should review the policy for bringing personal home appliances into the workspace.

Candles and other open flames should not be allowed in the workplace.

Poor housekeeping standards is a common cause for trip and fall. Office occupants should be encouraged to maintain clear access to the exit.

Employees should be encouraged to use ergonomic guidelines when establishing office space. Desks with sharp 90° connection points create an awkward position for prolonged typing.

In Rooms 105 and 109, the bookcases should be secured to the wall. Tall items such as bookcases are known to tip over during seismic activity.

The unisex restroom should have an occupied indicator latch. Currently, occupants must call out when the door handle is rattled.

The emergency exit is obstructed by a dumpster and a disabled van. The items belong to tenants in a neighboring business. Although the obstructions do not fully block emergency egress, it narrows the exit route. The site should contact property management and have the obstructions moved.
