Process for implementing Holidays into AVC Calendar	Dr. Lee /Scott Tuss	Issues Discussed: Dr. Lee states that Scott Tuss noticed a conflict of past practice of how the holiday dates were implemented in to the school calendar. Scott Tuss stated that when the Chancellor's office released the holidays, that some dates are mandate on a certain day, however some the college can decided when to take those holidays. Historically the classified union has met with administration to finalize those movable holiday dates. Scott Tuss stated that administration has decided to not follow past practice Dr. Vines stated that prior to his position of co-chair that may have been the past practice. Dr. Vines then state\d that this is a participatory governance committee and the decisions made regarding the calendar should be brought to the calendar committee. Dr. vines stated that he is willing to meet with the Classified union regarding the dates, but ultimately these dates will be finalized by the calendar committee. Pamela Ford stated that Classified union has always decided what day the holidays would be honored on and the academic calendar was decided by the faculty and those decisions were brought back to the calendar committee.

		Kyle Jacobsen referred to the AVCFT CBA Article X which states: "12.0 Calendar
		12.1 All issues related to the calendar (starting and ending dates of the
		semester, summer session and intersession; starting and ending class times; holidays; flex days; orientation; parts of term; days counted as instructional days) shall be referred to the Calendar Committee, a campus-wide standing committee. The committee will have co-chairs consisting of the vice-president of student services and either the AVCFT or AVCFCE representative in alternate years. Each year, the committee shall recommend a calendar to the presidents of the District, AVCFT and AVCFCE for final approval through a memorandum of understanding in time to meet the College's scheduling timelines."




