Board Policy is the voice of the board of trustees, and defines the general goals and acceptable practices for the operations of the college. It implements federal and state laws and regulations. The board, through policy, delegates authority to and through the chief executive to administer the college. The CEO and college staff is responsible to reasonably interpret board policy, as well as other relevant laws and regulations that govern the college. **Administrative Procedures** implement board policy, laws, and regulations. They address how the general goals of the district are achieved and define the operations of the district. They include details of policy implementation, responsibility and accountability, and standards of practice. They are developed and implemented by the CEO, administration, faculty and staff; they are not intended to require board action. (From the Community College League of California's "How to Guide")
