# 2014-2015 Academic Policies & Procedures Committee Meeting No. 2 MINUTES

#### 1. CALL TO ORDER AND ROLL CALL

A motion was made and seconded to call the September 25, 2014 AP&P Committee Meeting to order at 3:06p.m. Mrs. Linda Harmon, AP&P Faculty Co-Chair, called the meeting to order at 3:06p.m. Motion carried.

#### 2. OPENING COMMENTS FROM THE COMMITTEE CO-CHAIR

Mrs. Linda Harmon announced that the Chancellor's Office approved two new TMC degrees: Anthropology and Geography. She indicated that with today's review and hopefully approval of the AA-T in Philosophy our college will only be one degree away from our 100% compliance with the SB 1440 requirements. The AA-T in Spanish should be on the next AP&P agenda. Dr. Darcy Wiewall requested an update on the possibility of a catalog addendum as there are several students that would like to graduate with the Anthropology degree this spring semester. Dr. Bonnie Suderman suggested that Mrs. Melissa Jauregui and herself meet to discuss the details and encouraged Dr. Wiewall to be present as well. After this meeting, Dr. Suderman will provide an update for the committee.

#### b. First Reading: Substantial Course Revision (COR Complete / SLO Complete)

### i. CHEM 110, General Chemistry

A motion was made and seconded to approve CHEM 110, General Chemistry course revisions. Dr. David Newman was present to discuss the course revisions. After a brief review, the committee requested a revision to exclude the homework assignments and hours associated with "other." With the approval of the Dr. Newman, the change was made during the meeting. Motion carried. A second motion was made and seconded to approve the course content for CHEM 110, General Chemistry. Motion carried.

#### ii. GER 201, Intermediate German 1

A motion was made and seconded to approve GER 201, Intermediate German 1 course revisions. Ms. Heidi Preschler was present to discuss the course revisions. After a brief review, the committee requested edits as noted in the approval process, which were to bring the course content in line with the required outline format, adjust the homework section to reflect student work outside of class, and adjustments to the recommended textbook listing. Motion carried with only those revisions being completed by Friday, October, 3, 2014.

#### iii. MATH 220, Linear Algebra

A motion was made and seconded to approve MATH 220, Linear Algebra course revisions. Mr. Michael Tran was present to discuss the course revisions. After a brief review, no revisions were requested. Motion carried. A second motion was made and seconded to approve the course content for MATH 220, Linear Algebra. Motion carried.

#### iv. RCP 102, Clinical Preparation for Respiratory Care

A motion was made and seconded to approve RCP 102, Clinical Preparation for Respiratory Care course revisions. Mr. Jeff Stephens and Dr. Tom O'Neil, dean proxy, were present to discuss the course revisions. After a brief review, a question was asked regarding the number of course hours and homework hours in relationship to the units earned by students. Mr. Jeff Stephens was not sure how the

# 7. DISCUSSION ITEMS – AGENDA ADDENDUM a. Credit for Advanced Placement (AP) Exams

AP&P Minutes 9/25/2014 Page 7 of 8 Dr. Lee Grishman indicated that there is a need for AVC faculty to review the exams given for AP credit in six areas: Studio Arts, Environmental Science, Italian, Japanese, Chinese and Human Geography. He passed out the six exam packets to the corresponding division representative and requested that they coordinate with the faculty in the area to be sure the review is conducted. Faculty simply need to review the packet and determine whether incoming AVC students should be allowed to receive credit for the successful completion of those exams. He asked the representative to report back to the AP&P committee so an action item can be added to a future agenda.

#### b. In-class Reading and Writing Assignments

Mrs. Melissa Jauregui announced that the Chancellor's Office recently returned two courses for revision requesting in-class reading and writing assignments be noted on the course outline of record. In past years this data had not been collected and therefore a space currently does not exist within CurricUNET to capture this data. Dr. Bonnie Suderman indicated that she spoke with Mr. Edward Knudson, AVC President, who indicated that the information will be requested during the COR review process from this point forward. When the course outline of record is due for revision, then the faculty can note the in-class reading and writing assignments at that time. Mrs. Linda Harmon indicated that the section could be listed in the Homework link of CurricUNET but a formal change to the system will be brought to AP&P first before the change is made. This will return to an AP&P agenda in the spring for approval so the section can be available to collect the data as of Fall 2015.
