1. CALL TO ORDER AND ROLL CALL

The Distance Education and Technology Committee meeting of October 28, 2014, was called to order at 3:30 p.m. by Dr. Nancy Bednar and Dr. Charlotte Forte-Parnell, Co-chairs.

2. OPENING COMMENTS FROM THE CHAIRS

• Dr. Charlotte Forte-Parnell recapped a meeting she attended with Bonnie Peters, regarding the Online Education Initiative (OEI). Five classes will be tested, taught and evaluated. Antelope Valley College (AVC) will receive the benefits of design and accessibility. Currently the Poli Sci 101, English 101, Child Development, possibility Math and one other course are being considered for the pilot. Faculty will submit the questionnaire to Ms. Peters who will submit those in the pilot. Dr. Parnell stated faculty need assistance in how to best complete the questionnaire.

A module will be available to those teaching the courses, and will be made available to AVC student to assess the online course. Members identified a concern for authentication of our students signing in. AVC will have program designers available – seasoned faculty to help with building the classes and ensure their accessibility to all.
