IV. Approval of Minutes	All	A. February 28, 2017 Meeting (attachment) A motion was made and seconded to approve minutes of the February 28, 2017 DETC meeting. Motion carried unanimously.	
V. Discussion Items	Perry Jehlicka	A. Inclusive Access - Dawn McIntosh (attachment) Dawn McIntosh addressed members to discuss <i>Inclusive Access</i> - see attachment. The <i>Inclusive Access</i> program is a new textbook model in collaboration with top publishers that converts books into digital content. Discount rates can vary. Participants will need access to a	



		computer or laptop and must opt in and out. Instructors would make the digital textbook available to students before the class begins. Dawn asked members to provide feedback via email, or by stopping by her office in the bookstore.
	Perry Jehlicka	B. Goals Perry distributed goals.
	Perry Jehlicka	C. Mentor Program Members agree a point person is needed for online teaching. Perry emailed Kristine Oliveira regarding the mentorship project but didn't hear back. He noted that gathering information for programs on other campuses can be helpful, but AVC's mentorship program will need to meet the needs of our campus. Because there is no point person to assist online faculty with teaching, Perry would like to establish a mentorship program to include 4-5 instructors that can mentor online faculty across divisions. The program will begin in fall and will evolve after the first year.
		Mentors could receive flex credit or possibly pay. Student Equity is a possible funding source. Perry will meet with Kristine tomorrow to see how mentoring could fit into the Faculty Professional Development program.
		Mentors will collaborate in summer; workshops will be offered. DETC will identify a group and determine standards. Possible mentors include Dr. Ed Beyer, John Toth, Charles Hood, Dr. Nancy Bednar and Kathryn Mitchell.
		Dr. Suderman agreed to outside help, but questioned whether it would be best. Perry will ask for Greg Krynen's opinion.

DETC GOALS FOR THE SCHOOL 2016-2017

- 1. Develop a faculty mentorship program that educates faculty in the principles of instructional design in order to enhance the quality of online courses.
- 2. Provide the faculty with support to facilitate a smooth transition from Blackboard to Canvas.
- 3. Recommend a minimum training standard for online instruction to the Faculty Senate.

INCLUSIVE ACCESS

Inclusive Access is a newer concept that allows immediate access to the selected textbook for all students.

When a student registers for class and pays the fees, they are given access to the textbook, digitally, beginning the first day of class. (Access dates can be negotiated).

Our understanding is that all students will have access for a 14-day period. Once that time frame is complete, the student must "opt-out" of the program or they will be charged for the digital book and components. There is also an option to "opt-in" if the student determines, after they have "opted-out" that they really need the information, they can just click back in and continue along.

The communication regarding the "opt-out" would ideally come from both faculty and the Marauder bookstore – the bookstore would send a minimum of 3 emails explaining the process, the start and end trial dates, and the "opt-out" deadlines. The faculty utilizing the product would mention during class the importance of the dates.

It is critical that the faculty member assign something in the packet within the first 2 weeks so that the students can see how the platform works and why it will help them be successful in class.

These statistics we were provided are from a 2 year school in Canada:

ABC grade: with access 77% without access 66% DF grade: with access 15% without access 23% Withdraws: with access 7% without access 11%
