Discussion about possible elimination of mailed paper class schedules (from Marketing Committee) and the effect on e-mail service and dependency. Current 200GB message store must be reduced in size in preparation for migration of all mail into Luminis 4 (the new myAVC) over Spring Break. Mike reported that approximately 100GB of that message store is utilized by approximately 16,200 e-mail account holders. Speculation is that most of these are employee accounts. Actions to be taken that will reduce the size of the message store are:

- 1. Purge all e-mail messages from accounts that have not been used in one year or more and the account holder is not currently enrolled.
- 2. Inform and train e-mail users on myAVC e-mail housekeeping practices. ("Help us help you make our system better and faster.") Users need to clean up their myAVC e-mail, purging that mail after downloading it to their office computers if applicable.
- 3. Identify accounts with excessive mail storage and work specifically with those users on housekeeping.
