1. CALL TO ORDER AND ROLL CALL

Mr. Christos Valiotis, Academic Senate President, called the February 16, 2011 Academic Senate meeting to order at 3:04 p.m.

2. OPENING COMMENTS FROM THE SENATE PRESIDENT

- Mr. Valiotis welcomed Senators to a new semester and stated he is confident faculty will have a successful semester. He encouraged Senators to convey to constituent faculty the availability of the Senate Office and Staff to assist them in any academic and professional matter. Faculty should contact the Senate with any questions or concerns they may have.
- The budget information for the academic year is similar to the news the District was provided during the 2010 2011 academic year. A District budget overview was provided at the Spring Welcome Back Day and shows another year of uncertainty. If the tax propositions are not passed in November the budget news will be even worse for the 2012 2013 academic year. The bottom line is that the District to start planning now to adequately prepare for additional budget cuts and avoid deficit spending. Most likely there will be additional is course sections reductions. The chancellor's office is taking measures to ensure that the 10,000 FTE level is reduced accordingly so that we do not get penalized if we fall below. More budget information will be provided when announcements are made by the State.
- At the end of the fall 2011 semester it was reported nine faculty positions were announced to be hired for the 2012 2013 academic year due to replace retirees and fill grant needs. Six of the positions were to be funded by the District and three were to be funded by grant monies. Given the uncertainty of midyear cuts the District has decided to postpone five of the faculty hires contingent on District funding at this time. In addition, the Administrative position of Vice President of Student Services position has also been placed on hold. The District will go forward to hire a Fire Technology faculty due to the necessity for a Full-Time Faculty being needed in this discipline to meet program requirements. The three grant funded faculty positions will be hired as originally planned. The Strategic Planning and Budgeting Council also approved 11.5 full-time Classified positions during the fall 2011 semester but these anticipated hires have also been reduced to 4.5.
- The former Senior Administrative Assistant for the Vice President of Academic Affairs, Ms. Crystal Ellis, has been transferred to the Office of the Vice President of Student Services. It was anticipated she would facilitate a smooth transition for a newly hired Vice President of Student Services but due to the fiscal uncertainty this hire has been placed on hold. The District is going forward in advertising the position for a new Senior Administrative Assistant for the Executive Vice President of Academic Affairs.

3. OPEN COMMENTS FROM THE PUBLIC

• Mr. Ron Chapman stated at the December 2, 2012 Social and Behavioral Sciences Division meeting the faculty discussed the reported savings amount the District realized by closing the campus facilities over the summer. This came at a great cost to faculty who were unable to get into their classrooms to perform inventories, etc. The Administration has not made an account for savings and informed the campus constituency on how the money was redistributed. The discipline faculty of Social and Behavioral Sciences would like the Academic Senate to recommend a presentation be coordinated to detail how the cost savings for closing the campus during the summer was distributed. Ms. MaryAnne Holcomb stated many faculty are questioning the realized savings amounts and where the money is being distributed. The Business, Computer Studies, and Economic Development Division is losing more full-time faculty and are frustrated by the lack of replacement. The District is realizing savings in loss of personnel which are not being replaced. Where is the cost savings for the loss of full-time

faculty personnel being distributed? The division once included twelve full-time faculty members. They will be down to six full-time faculty beginning spring 2012. Mr. Valiotis indicated he would coordinate the opportunity for Administration provide a cost savings presentation at the next Senate meeting, as well as include a discussion item to further discuss the issue.

- Mr. Terry Rezek reported he has been in contact with an Enterprise who is willing to offer software training to the campus as a professional development opportunity. The training could be offered through the flex program and provide software training to both faculty and students. This would be one way to alleviate some of the training issues on campus, as well as provide Information Technology Services the opportunity to focus their energy in alternate areas other than training.
- Mr. Larry Veres, Adjunct Faculty Representative, stated he really appreciates the availability and opportunity to participate in the spring Faculty Welcome Back Day. It is a great opportunity for adjunct faculty to meet their Faculty Professional Development obligation prior to the start of the semester.

4. APPROVAL OF MINUTES

A motion was made and seconded to approve the December 1, 2011 Academic Senate meeting minutes. Motion carried.

5. **REPORTS (5 minutes maximum)**

a. Accreditation – Tina McDermott

Ms. Tina McDermott, Faculty Accreditation Co-Chair, reported she is working on the writing the Accreditation Follow-Up Report. The Accrediting Commission is requesting the District address the four recommendations needing to be addressed based on the Self Study Report. The Accreditation Standards are established with subset of each Standard. The following standards need to be readdressed in the Follow-Up Report and forwarded to the Commission for review/approval:

Recommendation #1:

Standard 1a/b/c/d – This standard primarily deals with the integrated planning process which includes Student Learning Outcomes (SLOs), Program Learning Outcomes (PLOs), Strategic Planning and Budget Council (SPBC), Educational Master Plan, and Program Review. Ms. McDermott stated these constituency groups don't communicate effectively so she is working with the individual constituency groups to create a communication plan to meet Accreditation requirements. One of the major issues in this area relates to SLOs and assessment. The District needs to demonstrate 100% compliance in SLO assessment and action plans. Faculty need to be on board to get data entered into WEAVE to ensure the District meets this accreditation requirement established for all California Community Colleges. It became apparent that there was a misunderstanding on who was expected to enter WEAVE data and how the data was to be entered. All personnel issues are being addressed accordingly which should increase the compliance numbers. Recommendation 1D specifically addresses Program Learning Outcomes (PLOs). The District needs to demonstrate how individual programs are making efforts of improving.

Recommendation #2:

Standard 2A – The commission recommended that the District demonstrate the consistent work and progress of campus advisory committees. The District has twenty campus advisory committees that need to be consistent in documenting meetings, work performed, and committee progress. The individual advisory groups are aware of the necessary requirements needed to demonstrate compliance.

Standard 2B – The Commission recommended the District incorporate a consistent Program Review report process. The Program Review Coordinator is working on creating a uniform Program Review reporting process and has been working with the SLO Faculty Co-Chair, Ms. Melanie Parker, to incorporate SLO/PLO data to support findings in order to support funding requests. The Program Review Committee is developing a standardized rubric for Peer Review Team members. This will create a clear understanding of what a faculty/staff/administration should expect to see included in Program Review Reports.

Standard 2C – The Commission recommended a thorough comparative analysis with similar sized community colleges be performed to determine if adequate Library services are being offered. The District needs to address and demonstrate how deficiencies will be addressed.

Standard 2D – The Commission recommended the District further demonstrate how Information Technology (IT) administrative issues will be addressed. Mr. Calvin Madlock, Director of ITS, has performed an IT needs assessment to begin addressing this recommendation. In addition, he has instituted a quarterly process of needs assessment for academic computing issues.

Recommendation #3:

The Commission recommended the District address and demonstrate a plan to address campus Network Security. Mr. Madlock is working on incorporating wireless on campus. The initial phase will be to incorporate wireless within the new Math and Health Science building. More infrastructures are needed to incorporate campus wide. Wireless will be rolled out in phases as infrastructure is established.

Recommendation #4:

The Commission recommended the District address GASP funding which is an employee benefit funding. Business Services has established a projection plan to demonstrate how this recommendation is being addressed, however the District cannot move forward with this plan due to the current budget constraints.

Mr. Valiotis indicated Ms. Melanie Parker – SLO Faculty Co-Chair, Mr. Ted Younglove – SLO Administrative Co-Chair, Mr. Aaron Voelcker – Research Analyst, and Dr. Irit Gat – Psychology Professor have offered to personally assist any faculty member needing assistance with entering data in WEAVE. In addition, Mr. Valiotis requested Senators review that SLO/PLO data sheets provided to ensure the division and discipline has submitted data into WEAVE accordingly. Any miscommunication on who is responsible for entering data for various disciplines will be resolved in the immediate future.

Ms. Parker emailed the following statement to clarify the issues relating to attached SLO/PLO data sheets:

"Please note that the SLO/PLO compliance lists forwarded as attachments for today's Academic Senate meeting only reflect SLOs and PLOs that have been entered correctly into the WEAVEonline database. There are SLOs and PLOs that have been written and approved but may not have been entered correctly into WEAVEonline or have not been entered into WEAVEonline. Several programs and courses do indeed possess approved outcomes, assessments, and these results that are not accurately reflected on this lists. The lists reflect the need for each program/discipline area to review appropriate course and program information to ensure data has been entered into WEAVEonline, and are therefore readily available to demonstrate compliance."

Mr. Valiotis stated the Accrediting Commission Report of Institutional Actions from the January 10 - 12, 2012 meeting included seventeen community colleges that have been placed on warning or show of cause. Senators were encouraged to review the list which is posted on the public AVC website on the Accreditation page and ensure the campus community remains diligent in ensuring we are accumulating evidence to demonstrate compliance.

b. Distance Education & Technology Committee (DETC) – Rick Balogh

Mr. Rick Balogh reported the Distance Education and Technology Committee will be meeting on Tuesday, February 28, 2012 to determine the future campus Course Management System (CMS). The committee is researching switching from the current CMS, Blackboard, to either Etudes or Moodlerooms. Faculty have been experienced continued frustration with the Blackboard CMS platform system due to th unreliability of the platform, as well as the costs to maintain Blackboard as the campus CMS platform. Blackboard fees has been communicated to be 140k for the first contract year and then increases 3% each year for a three year contract. Mr. Balogh provided a brief overview of information obtained through research of Etudes and Moodlerooms.

Etudes – this CMS platform mandates faculty training. Etudes reliability is almost 100% and all platform upgrades are implemented in small segments. Originally, this platform system was less

expensive than Moodleroom which had a fee of 84k a year with the first year discounted 50% but Moodlerooms has matched this fee. At the spring Faculty Welcome Back Day Mr. Balogh stated he was promoting the strong possibility of contracting with Etudes based on the research and contracting fees.

Moodlerooms – this CMS platform does not require faculty training and works on the system where those trained are expected to assist in training other campus constituents. Mount San Antonio College recently switched to Moodlerooms from Blackboard and is going through the transition process. The faculty have expressed their discouragement with the training process. Moodlerooms includes more technological features and tools which are similar to Blackboard. In addition, Moodlerooms includes unlimited storage for course shells and content. Moodlerooms has a poorer record of downtime compared to Etudes.

Mr. Balogh stated DETC members have received passwords to access both Etudes and Moodlerooms to test and play with courses. The committee will make a decision of which platform to recommend to the Academic Senate at the upcoming DETC meeting.

Mr. Valiotis stated it is important to include all campus faculty in the CMS decision. All faculty teaching online should be solicited to test the two prospective CMS and requested to provide input so a holistic decision is made. Senators were requested to inform constituent faculty of DETC work to determine the campus CMS and should make efforts to contact Mr. Rick Balogh to obtain access to the testing site. Faculty teaching online should make efforts to become part of the decision-making process by forwarding their feedback to Mr. Balogh for inclusion in deciding which CMS platform to contract beginning fall 2012.

Mr. Balogh indicated he would disseminate a campus wide email announcing the work of the committee, as well as the links to the testing site for faculty to access. He also provided a brief update on the issue of Faculty rights for Computer Use. The Senate tasked the committee to develop a Faculty rights for Computer Use Procedure. The DETC sent out an email requesting input on specific language or issues that should be included in the policy language. To date, only one response has been received which does not assist the committee in establishing language that is inclusive of all faculty computing issues. Mr. Balogh indicated he will distribute the email requesting faculty feedback to acquire more feedback to complete the task given to the committee to complete. Please encourage discipline faculty teaching online to assist in this process and provide input of policy language which should be included in the draft.

c. Program Review – Carol Eastin

Ms. Carol Eastin reported tremendous Program Review progress has occurred over the Intersession.

The Program Review Committee has been working on determining modifications needed to the current Program Review Procedures to standardize the reporting process. In addition, the committee is reviewing necessary elements that need to be included in future reports to meet Accreditation requirements. There committee needs to make efforts to move forward to include specific SLO data results in future Program Review Reports. Discipline faculty will need to speak to how SLO data results have changed course sections and the expected outcome of changes made to course sections. Program Review Reports will then become part of the demonstrated evidence for Accreditation purposes.

Dr. Susan Lowry expressed her concern with the idea of the reports becoming more data driven than narrative based. For some Language Arts Disciplines it will be difficulty to incorporate and use data as the primary element in future Program Review reports. Discipline faculty don't deal usually deal with interpreting data and will definitely need training and assistance on how to incorporate SLO data. Ms. Eastin stated when discipline faculty begin incorporating data results they need to look at course trends and speak to education trends. The committee will work to provide examples from other disciplines as models.

Mr. Christos Valiotis stated there must be a campus wide effort to ensure the planning processes tie into each other (i.e SLO, Program Review and SPBC). There is a definite need to connect the classroom needs to the budgeting and planning process and using SLO data in Program Review Reports will accurately reflect the needs at the course level.

6. ACTION ITEMS

a. AP&P Recommendation for Approval: Course Revisions, New Courses, Obsolete Courses, and Revised Degrees (attachment)

A motion was made and seconded to approve the AP&P recommendation to approve Course Revisions, New Courses, Obsolete Courses and Revised Courses identified on the attachment. Senators were referred to the attachment and indicated the list displays the work performed and approved during the fall 2011 semester. Motion carried.

b. Equivalencies:

• Child & Family Education (attachment)

A motion was made and seconded to approve the Child & Family Education Equivalency. Discipline faculty deemed additional equivalency language is not needed for the discipline. Motion carried.

7. DISCUSSION ITEM

a. Hiring Procedures: Executive Vice President of Academic Affairs Role in Hiring Committees Mr. Valiotis stated a request was made at a Mutual Agreement Council meeting regarding the role of the Executive Vice President of Academic Senate and Student Services on hiring committees. It was requested the Senate discuss revising the current Hiring Procedure to allow the Executive Vice President the flexibility to participate as a member of the hiring committee at the beginning or end of the process. When multiple hiring committees occur at the same time it becomes increasing difficult for the Executive Vice President to schedule hiring committee meetings due to other administrative obligations therfore delaying the hiring process. In addition, Mr. Valiotis stated if the Hiring Procedure is going to be reviewed to allow the Executive Vice President flexibility in participate in the hiring process then the Senate should also consider revising the process to include a second interview process. He stated it is difficult to get a full perspective of candidates teaching ability without a second interview where a full teaching demonstration can be facilitated.

Dr. Susan Lowry requested any decision on revising the Hiring Procedure should be delayed until the entire faculty constituency is informed of the requested changes and provide input on the matter.

Dr. Lee Grishman stated the request for flexibility of the role of the Executive Vice President is a temporary change based on the amount of active hiring committees. This wouldn't require for the Hiring Procedure to be changed as a whole but simply to incorporate a designee for the Executive Vice President of Academic Affairs and Student Services which would resolve the immediate issue.

Mr. Valiotis requested Senators take this request and suggested change to constituent faculty for discussion and input for full discussion at the March 15, 2012 Senate Meeting.

b. SPBC (Strategic Planning & Budget Council) Procedure

Mr. Valiotis reported SPBC meets two times a month during the semester and during the Intersession and Summer months as needed. The Council has been discussing whether the Council approves funding or actual positions. These questions are a great debate and there is a need to have the true nature of actions spelled out so that council members are aware of what they are approving. There are obvious procedural issues that relate to how Program Review, SLO, and Division level funding. The issues conveyed at this level do not make it to the SPBC table for discussion or approval. There is a definite need to tie up the communication process of classroom level needs to SPBC level. Mr. Valiotis suggested reviewing the current process and procedure that is currently incorporated and research other community college processes to determine the best possible solution on how to address and resolve these issues. There is a need to review the current SPBC process, Program Review process, and Accreditation requirements to determine the best possible solution on how issues are communicated to the larger SPBC body. There is a small constituent group of SPBC members (Mr. Christos Valiotis, Dr. Lee Grishman, Mr. Ted Younglove, and Ms. Pam Ford) who are reviewing the current process, conducting research, and will ultimately present findings to the entire SPBC constituency for further discussion and possible recommendation of changes needed to improve effectiveness. Mr. Valiotis stated his personal opinion is the District needs to improve effectiveness which requires tying up all the loose ends. One of the main issues the group will work on addressing is how to make the committee more relevant in seeing the needs at the course level. The subgroup is set to meet again in the near future and when all information has been obtained will present the information to the Senate. Mr. Valiotis indicated he expects the information will be ready to present to the Senate at the March 15, 2012 meeting.

c. Assembly Bill Implementation: Student Success Task Force

A motion was made and seconded to table this discussion item until the March 1, 2012 Senate meeting due to meeting time constraints. Mr. Valiotis requested Senators review the language in preparation for full discussion at the next meeting. Motion carried.

The following course revisions were reviewed and approved by the Academic Policies and Procedures (AP&P) Committee during the Fall 2011 semester:

New Course Development

HD 102, Readjustment Strategies for Veterans, Their Families and Friends 1.5 units, 24 hours total Advisory: Eligibility for or concurrent enrollment in ENGL 099 and READ 099. The course is intended for all veterans who served during wartime, their family members, friends and supporters to learn ways for veterans to adjust to civilian life and to college. Students will examine and discuss various physical, emotional and psychological reactions to wartime service, whether exposed to combat or not, and how these effect veterans' civilian readjustment. Students will explore various coping mechanisms that will enable veterans to reconnect with loved ones and manage stress and anxiety related to the wartime experience. In the course, students will explore the signs and symptoms of Posttraumatic Stress Disorder (PTSD) and Military Sexual Trauma (MST) and identify strategies for managing these symptoms. The course will enable students to identify community resources that may enable readjustment to civilian life.

LAC 020, Managing Writing Anxiety 1 unit, 1 hour weekly Advisory: Eligibility for ENGL 097 and READ 097. Students will be provided with various coping skills to reduce writing frustrations in college and beyond. Course topics include symptoms of writing anxiety, pro-active strategies to control it, identification of essay elements, learning style preferences, and the application of stages of the composition process to different writing situations. Students will also develop their knowledge and use of available instructional resources as they increase their skills to successfully manage their writing anxiety.

- **ART 150, 3-D Design Basics** 3 units, 2 hours lecture/4 hours lab Advisory: Eligibility for ENGL 099 and READ 099. Instructional materials fee required for this course and must be paid at registration. An introduction to the application and theory of design elements and art principles common to all visual art forms. Students will solve 3-dimensional visual problems using a variety of mixed-media. The course will explore composition from the beginning of Art History to contemporary trends. Students may have to purchase additional supplies not provided by the college.
- SOC 200, Research Methods for the Social Science 3 units, 3 hours weekly Prerequisite: Completion of MATH 115 and one of the following: ANTH 101, ANTH 102, ANTH 140, POLS 101, POLS 202, PSY 101, or SOC 101. This course is designed to introduce students to the process of empirical research. It covers both qualitative and

quantitative research analysis and both experimental and non-experimental research strategies in detail, including surveys, observational, case studies, and comparative historical research. The practical application of these methods in a contemporary setting is emphasized. Ethical issues will be examined for both human and non-human subjects as well as an overview of computer applications frequently used in social science data analysis.






