Janice Oliver stated that there was a problem with ACCESS and the pickup location the night of Camp Coming Home event on Thursday, October 18, 2012 concerning the dislocation of student pick up. Sandra specified that there is only one passenger loading zone which is meant for theater goers to drop off passengers in front of the theater. This is preferable location due to the stop signs and they are working on perfecting the situation. Sareena stated that she is working on a petition to resolve the problem seeking progression.

# **5.1 ASO Committees and Appointments**

Dr. Zimmerman stated that accreditation are the outside agencies that validates all degrees, and the agency that accredits AVC is the Western Association of Colleges and Universities which is what makes one's diploma have value. They are looking for a three pronged chair which consists of a Dean, a faculty member and are asking for a student to be on one of the four standards. As of now they are looking to form a committees. The other committee they want to form is the Student Court. Discussion about who was interested in joining what committee was deliberated.

There will be an ice breaker, a session from NCSL, a session from General Assembly and one from Alpha Iota, as well as a close session. It was discussed that those wanting to attend must submit \$5 prior to their attendance as a deposit which they will get back when they receive their food. The possibility of using the leftover money from the

Homecoming budget for the Leadership Workshops was discussed. A marketing email will be sent to encourage students to attend. The name will be the School Sprit Leadership Workshop. There will be no ASO meeting that day because everyone is expected to attend the leadership workshop.

ASO shirts for the Officers and Senators as well as volunteers was discussed and how they can be used to promote advocacy. Alvaro volunteered to work on a design for the shirts.

Moved to approve up to \$1,200 from the Student Representation Fee for advocacy and promotional shirts by Rienana Paul, seconded by Alvaro Wong, Motion passed 8/0/0.
