#### Introduction:

In April 2022, the chair of the committee transferred from the Dean of Student Life to the Associate Dean of Student Life because of an institutional reorganization. The mission for our team has remained: to directly engage students in their knowledge, information, and actionable participation in civic and voting responsibilities.

For the June 7, 2022, State primary election, AVC published the "Every Vote Counts" campaign encouraging the campus to register and to vote via email, the LED corner sign, the college webpage and social media outlets.

November 8, 2022, the general interim elections were held. District 27 garnered a competitive race for the congressional seat with incumbent Mike Garcia (R) and opponent Christy Smith (D). AVC held two candidate forums on campus for students and the community. Both were well attended and available both in-person and online, 120 in-person RSVPs for Mike Garcia's event and 93 for Christy Smith's. Mr. Garcia was the successful candidate with 52.3% of the votes.

### As a team we accomplished the follow activities:

- Updated Voter and Civic Engagement page under AVC website.
- Formed a 2022 action plan to host events and helped make voting more accessible.
- Faculty members Tina Leisner McDermott's Honors class assignment focused on different aspects of voting and the speeches were shared publicly via a ZOOM link.
- Hosted voter registration opportunities during campus events:
  - o June 18, 2022, Juneteenth Celebration
  - o August 17, 2022, Opening Day event
  - o October 15, 2022, Para la Gente Celebration
  - October 22, 2022, Home Football Game
- AVC's "Umoja" Program under the Student Equity department utilized the Umoja Village and "Porch
  Talk" sessions in 2022 to help create a casual space where students could come chat with each other,
  families, faculty, staff, and community members about various topics. The Umoja Community
  supported Voter Registration by promoting a voter registration opportunity at our annual Juneteenth
  Celebration and promoting other Civic and Voter Registration events on our community wall and
  bulletins.
- SOAR High School's "GirlsBuild" chapter, continues to challenge young women from public middle and
  high schools across the country to make an impact in their community and ensure that their voices are
  heard. We believe young women will define the vision for what our schools, communities, and country



can be, and that work starts now. Their focus is on voter registration and pre-registration of students 16 and 17 years of age. The goal of all the local Girl Build chapters was to have 10,000 new registrants. The SOAR GirlsBuild team focused on properly preparing the student body for the future by providing various resources to college graduates, career info, etc. They held multiple workshops regarding the importance of voting with Professor John Vento and even met with Lancaster's City Clerk. • The Civic and Voter Engagement Committee consisted of a team that organized and hosted AVC's Congressional Candidate Forums. Fritz Hemker, Tina McDermott, and John Vento facilitated the forums asking questions submitted by the students and community. The committee was also active in making flyers and posting while also posting and passing them out on campus. They also tabled at various events including the football game to drive voter registration and promote the forums. During AVC's Juneteenth event they brought voter awareness to nearly 250 attendees. They effectively worked alongside student volunteers and their Student Trustee to get the job done. Furthermore, the committee secured support from ASO for the upcoming school year and semester.

One of the main ways our campus targeted voter engagement was a mass information on the issues on the November 8th election ballot and the importance of registering to vote and exercising your right to vote.

Flyers containing all pertinent California voter information and deadlines per the California Secretary of State website were dispersed both virtually and in person to meet the needs of all our students.

Antelope Valley College served as a polling location for the November 8th election.

To continue to engage the campus community through a distanced learning environment our team repeated successful strategies from the year before. Faculty and staff were able to choose to change their email signature to include important voter registration information. We also modified our website to include voting resources for students and the results of the election. This page continues to reference the California Secretary of State's voter information page to properly inform our community. We provided access to accurate election information about less well-known aspects of voting like state-wide propositions or county level judges who may be up for election.

The Associated Student Organization (ASO) used funding for our annual Constitution Day essay competition. This competition is facilitated by John Vento. This year there were 166 essay submissions and five awardees with prizes ranging from \$25-\$500 with the following prompt: "Which constitutional amendment do you think is most important, and why? Use specific evidence and references to the Constitution to support your answer." Students were required to write no more 1880 words, 12 font, double spaced, in MLA format and include at least three citations.

Tina Leisner McDermott continued to advocate for civic engagement through her Public Speaking courses. Her students research topics related to voting, and any issue impacted by voting, for their informative speech assignment. Some examples of topics students choose to speak about are LGBTQIA+ rights, California ballot propositions, issues in the prison system, the Electoral College, Supreme Court cases, amendments to the Constitution, DACA, immigration issues, mail in ballots, women's fight for suffrage, age requirements for voting, etc. Students who take this course learn the importance of voting and the impact of it on their lives from local, state, to federal policies. Throughout the semester, Professor McDermott continuously encouraged students to register to vote and shares any relevant links or voting information with her classes. Students in her classes consistently stated that they gained a greater awareness and appreciation for the importance of voting through this course.

Our special population, Umoja, Student Equity, Dreamer Center, First Year Experience and Second Year Experience all supported the campaign to register students to vote. Special activities were incorporated into events sponsored by these programs. One of which was the history of special elections and past recalls in California. Students learned the importance of participating in the elections as they do not frequently occur.

The AVC Campus Team successfully informed the community about voter registration and the November general election information. Using online voting rights seminars, lists of important voting dates and deadlines, and candidate coverage, the team spread awareness throughout the campus. There were more than 10 outreach events for students, informing them how to access voting information and assisting them with registering to vote. In the Ballot Bowl Competition, AVC recorded 72 registrations.



The success of the team supports the mission and brings awareness to voter registration, issues and candidates and need to get out the vote.
