# Issues

- Program Review - Effective Fall 2026, the Program Review Committee recommends transitioning Program Review to a four-year comprehensive review cycle with annual updates.
- State mandates - This summer, CCN Faculty Workgroups convened to develop course templates on 47 courses across 18 disciplines.
- AI - On July 23, 2025, Instructure (Canvas LMS) announced a global partnership with OpenAI, unveiling a new integration that embeds advanced artificial intelligence capabilities directly into Canvas.
