### **DUTIES**:

- Responsible for teaching 15 Lecture Hour Equivalents per semester in the Commercial Music program
- Responsible for five office hours per week, plus classroom preparation hours, and service to the district and the community totaling to a workweek of not less than 30 hours
- Ability to teach all levels and types of Commercial Music classes including; Performance Ensembles such as Rock Band, technical courses such as Studio Music Production, Commercial Music/Music Theory, as well as lecture based courses that include music related history courses
- Responsible for curriculum development and maintenance
- Participation in the creation, assessment, and planning related to Student Learning outcomes as well as participation in the Program Review process
- Responsible for establishing and maintaining an effective advisory committee
- Participation in hiring committee of new adjunct instructors
- Evaluate and select instructional materials such as textbooks, manuals, software, and tools in collaboration, with discipline faculty; order instructional materials according to campus bookstore procedures to ensure timely delivery
- Participate in department, division, and college-wide meetings, committees, and initiatives
- May be assigned courses that require travel between District Locations
- May be assigned a combination of daytime, evening, and weekend classes

- 4. **Transcripts** from <u>ALL</u> college work, to include showing degrees conferred, from an accredited institution(s).
  - Unofficial transcripts or photocopies will be accepted to establish the application file; however, official transcripts will be required if the candidate is offered the position.
  - b. Any degree from a country other than the United States., including Great Britain and Canada, must be evaluated by a professional evaluation service, and proof of such submitted with application.
- 5. At least two signed letters of recommendation; must be dated within the last one to two years.
  - a. These letters should pertain to professional experience, and are not general "character references." Applicants are encouraged to request more than two letters to ensure that at least two are received prior to application review. No faxed or e-mailed copies will be accepted.
