ADN-Associate Degree (Except #)

- Minimum of 12 units must be completed at AVC (credit earned by examination will not be included in these 12 units)
- All courses must be completed with a minimum grade of C in all categories.
- Refer to catalog or online website for course listings, descriptions, and suggested course sequence if available.

LVN to RN Career Options

- Student must be a licensed vocational nurse (LVN) in California and be certified in I.V. therapy.
- Minimum age of 18, graduation from an accredited United States high school or equivalent (official sealed transcripts required), and be admitted to AVC
- A minimum grade of "C" is required in all courses
- None of the G.P.A. prerequisites for NS 101A apply towards admission of an LVN student bridging into the RN program under option A or B.
- All students are required to take the Test
 of Essential Academic Skills (TEAS®), and
 complete remediation if test indicates. A study
 manual for the TEAS® is available from
 Assessment Technologies Institute, LLC
 (www.atitesting.com) or the Marauder Bookstore.
- Students who have been unsuccessful on the TEAS® at another college must complete that college's remediation plan before taking the TEAS® at AVC.
- Students are required to have a background screening (no felonies required).

Degreed and Non-Degreed License

Students who complete all the required courses for the AS degree will qualify for the Degreed License once the Board of Nursing exams are passed. The license will allow the holder to practice as a RN in any state in the United States. Students without the AS Degree will earn a Non-Degreed License once the Board of Nursing exams are passed. There is no assurance that a Non-Degreed license will be recognized outside the State of California. The status of the license will be permanent and it will not change, even if, the student completes the other required courses for the AS degree after the initial license has been granted.

Important: New requirements are in place for students enrolling in the program in fall of 2015 and forward.

B. Advanced Placement Option

An LVN admitted to the second year of the ADN program can elect to receive credit for NS 101A, NS 102A, and NS203A for his/her LVN course work. LVNs must provide a transcript of their vocational nursing education and course description(s) showing content in maternal and newborn nursing and pediatric nursing. The units will be posted on the student's transcript after successful completion of NS 200A.

All prerequisites and General Education requirements for the regular ADN degree apply for this option.

C. Entrance into the Generic ADN Program

A Licensed Vocational Nurse (LVN) can choose to enter the generic ADN program beginning with NS 101A. The LVN who elects this route must complete the same prerequisites, entrance requirements, courses, and follow the same enrollment and selection procedures as generic nursing students.

Prerequisites to apply to the RN program

- 1. Graduation from an accredited United States high school or an approved equivalent.
- 2. Freedom from communicable disease as verified by a licensed physician or certified nurse practitioner. Other health conditions that could impair the student's ability to perform the essential functions of a nursing student safely and competently will be examined on a case-by-case basis.

Diagnostic Assessment (TEAS®)

Once a student has turned in an enrollment packet for the RN program and is found eligible for admission, the student will receive permission to take the Diagnostic

Assessment at the Assessment Center (T100).

<u>Diagnostic Assessment</u>: 3 hours & 30 minutes <u>Content</u>: English Usage, Reading, Mathematics, <u>Anatomy</u>, Physiology, Microbiology.

Students who don't pass the assessment the first time must complete the recommended pre-entry courses and retest within one year of the first test date.

Proficiency Requirements

Proficiency requirements exist for the areas of Reading, Writing and Math. Students must demonstrate competency in each of these areas in order to be eligible for the associate degree.

A. READING

Eligibility for College Level Reading (AVC assessment) or completion of READ 099 with a minimum grade of "P" (Pass), or completion of an Associate Degree or higher from a regionally accredited institution of higher education.

B. WRITING

Completion of ENGL 101 with a minimum grade of "C." NOTE: ENGL 101 may be taken with the Pass/No Pass option; however, students are cautioned that other colleges and universities may not accept ENGL 101 courses taken on a Pass/No Pass basis, especially for satisfaction of general education and major requirements. Students planning to transfer should check college catalogs for applicable policies.

C. MATHEMATICS

Completion of MATH 102 or higher or CIS 121 with a satisfactory grade or placement by AVC assessment into a math course higher than MATH 102.

*Fulfilling proficiencies will not require any extra units if the competencies are demonstrated by including the required courses in the general education, or major requirements, or by satisfying the reading proficiency through AVC's policy.

Grade Point Average Requirement

An overall grade point average of 2.0 ("C" average) is required.

Double Counting: While a course might satisfy more than one general education requirement, it may not be counted more than once for these purposes. A course may be used to satisfy both a general education requirement and a major or area of emphasis requirement.

Requirements for Two or More

Associate Degrees. To be eligible for multiple associate degrees, a student must have completed all of the graduation requirements for each degree.

Transfer. Students planning to continue studies at a four-year college or university after AVC should visit the Transfer Resource Center and consult with a counselor as soon as possible to develop a plan of studies. Transferability of courses to the CSU or UC systems is indicated at the end of a course description by the notation "(UC, CSU)." For the transferability of courses to all other universities, please consult with a counselor or the Transfer Resource Center.

- 2. Submit an Educational Plan obtained at AVC's Counseling Center. You will need one set of official transcripts from every institution, other that AVC, for the counselor's evaluation. If your prior education comes from a foreign country, you will need to have those foreign transcripts evaluated by one of the international evaluation services that AVC recognizes before a counselor from AVC can complete an Educational Plan. Request a list of international evaluation services at the Counseling Center. (661) 722-6338. Course descriptions must be submitted
- 3. Submit one set of official high school transcripts (or GED results) and college transcripts to the Career Technical Education (nursing department office) with the program enrollment form. (Transcripts/GED results must be received in sealed, unopened envelopes.) It is the student's responsibility to contact the high school and college(s) attended for official transcripts. The student should contact educational institutions early in the enrollment process. If the student has earned an Associates Degree or higher, then evidence of a high school diploma or equivalent is not necessary as long as the granted degree is posted in an official transcript as part of the application packet.
- Submit one extra set of official transcripts from every institution attended (including AVC) with the completed enrollment packet to the Career Technical Education (nursing department office).
- Transfer students must submit a letter from their previous nursing program director indicating that they are eligible to return to their former program.
- Consult with the Health & Safety Sciences (nursing department office) in regards to the selection procedure and the appropriate time for the background screening and the physical examination.

Prerequisite: If a course is listed as a prerequisite for another course, that prerequisite course must be completed with a satisfactory grade in order to enroll in the next course. According to Title 5, Section 55200(d), a satisfactory grade is a grade of "A," "B," "C" or "P". Students who enroll in classes for which they do not meet the prerequisites will be involuntarily dropped. Students will be notified of this involuntary drop.

<u>Corequisite:</u> A condition of enrollment consisting of a course that a student is required to simultaneously take in order to enroll in another course. Corequisites are enforced and a student will be blocked from enrolling if the student does not meet the stated requisite.

Advisory: A condition of enrollment that a student is advised, but not required, to meet before or in conjunction with enrollment in a course or educational program.

NS 101A FUNDAMENTALS OF NURSING SCIENCE Limitation on Enrollment: Formal admission to the Associate Degree Nursing Program, annual physical exam and tuberculin test, current immunizations, personal liability insurance, background screening, current American Heart Association Healthcare Provider basic cardiac life support card.

Prerequisite: Completion of BIOL 201, BIOL 202, and BIOL 204 with a 2.5 overall GPA. May only have one repeat in the sciences. Completion of MATH 115 and ENGL 101 with a GPA of 2.5 or better. Have an overall GPA of 2.5 in all course work. (CSU, AVC)

NS 102A MATERNAL AND NEWBORN NURSING <u>Limitation on Enrollment</u>: Formal admission to the Associate Degree Nursing Program, annual physical exam and tuberculin test, current immunizations, personal liability insurance, background screening, current American Heart Association Healthcare Provider basic cardiac life support card.

Prerequisite: Completion of NS 101A.

NS 103A MEDICAL SURGICAL NURSING I <u>Limitation on Enrollment:</u> Formal admission to the Associate Degree Nursing Program, annual physical exam and tuberculin test, current immunizations, personal liability insurance, background screening, current American Heart Association Healthcare Provider basic cardiac life support card.

Prerequisite: Completion of NS 101A, or NS 200A for LVN and transfer students. (CSU, AVC)

NS 200A NURSING TRANSITION

Limitation on Enrollment: Formal admission in the Associate Degree Nursing Program for Licensed Vocational Nurse (LVN) students and transfer students. All LVN students' transcripts must show evidence of maternity and pediatric course completion. All LVNs must possess an active California vocational nursing license and an Intravenous and Blood Therapy Certificate. Transfer students must submit a letter from director of their previous program indicating eligibility to return. All applicants must have a current physical exam and tuberculin test, current immunizations, personal liability insurance, Live Scan, current American Heart Association Healthcare Provider basic cardiac life support card.

Prerequisite: Completion of BIOL 201, BIOL 202 and BIOL 204 with a grade of "C" or better. Completion of MATH 115 with a grade of "C" or better. Completion of ENGL 101 with a grade of "C" or better. (CSU, AVC)

NS 201A PSYCHIATRIC-MENTAL HEALTH NURSING <u>Limitation on Enrollment</u>: Formal admission to the Associate Degree Nursing Program, annual physical exam and tuberculin test, current immunizations, personal liability insurance, background screening, current American Heart Association Healthcare Provider basic cardiac life support card.

Prerequisite: Completion of NS 102A and NS 103A, or NS 103A and NS 200A for LVN and transfer students. (CSU, AVC)

NS 202A MEDICAL SURGICAL NURSING II
<u>Limitation on Enrollment</u>: Formal admission to the
Associate Degree Nursing Program, annual physical exam
and tuberculin test, current immunizations, personal
liability insurance, background screening, current
American Heart Association Healthcare Provider basic
cardiac life support card.

Prerequisite: Completion of NS 102A and NS 103A, or NS 103A and NS200A for LVN and transfer students. (CSU, AVC)

NS 203A PEDIATRIC NURSING

<u>Limitation on Enrollment:</u> Formal admission to the Associate Degree Nursing Program, annual physical exam and tuberculin test, current immunizations, personal liability insurance, background screening, current American Heart Association Healthcare Provider basic cardiac life support card.

Prerequisite: Completion of NS 201A and NS 202A (CSU, AVC)

NS 204A MEDICAL SURGICAL NURSING III Limitation on Enrollment: Formal admission to the Associate Degree Nursing Program, annual physical exam and tuberculin test, current immunizations, personal liability insurance, background screening, current American Heart Association Healthcare Provider basic cardiac life support card.

Prerequisite: Completion of NS 201A and NS 202A. (CSU, AVC)

NS 205A TRANSITION TO PROFESSIONAL NURSING
