Credentialing/CoARC Benchmarks: Wendy gave an over view on how the program is doing with Credentialing and stated that we currently meet all of CoARC benchmarks. We received a second year 90% success rate for RRT for the 2019 class. In 2019 80% of graduates obtaining CRT was the bench mark. The new benchmark is 60% of graduates will test at the high cut score on the TMC we meet that for the 2019 year.

Strong work force proposal. Wendy Spoke about the need to update the RCP lab with mechanical ventilators, computers, charting software and more. The committee agreed there was a need to upgrade the lab. The committee felt that it was import to update simulation lab and approved the t process to Acquire funding and equipment to support educational activates in computer-based charting, communication and pediatric and neonatal patient care skills. The projected cost is \$165,000

Internships-At this time due to the change in calendar year there was a discussion on where internships could take place. This discussion will be brought back at the next meeting.

Pinning Ceremony: 2nd year students asked about pinning due to Covid-19 restrictions. Wendy Stated that at this time it is believed that no in person pinning will be done.
