#### Required Minimum Qualifications: (Applicant must meet one of the following requirements)

• Minimum Qualifications for Faculty in California Community Colleges:

Any Bachelor's degree **AND** two years professional experience **OR** any Associate's degree **AND** six years of professional experience. (Academic Affairs Division, California Community Colleges)

#### Area: CAD (Computer Aided Design)

- College work, military training, or nationally recognized certifications equivalent to a Baccalaureate degree and two years of related occupational experience in the discipline; or, college work, military training, or nationally recognized certifications equivalent to an Associate's degree plus six years of occupational experience related to the discipline, OR
- Eight years of experience in the design and development occupation, two years of which must have included assignment as a supervisor, instructor, trainer, or owner of an aircraft maintenance facility.

#### Area: CAM (Computer Aided Manufacturing)

- College work, military training, or nationally recognized certifications equivalent to a Baccalaureate degree and two
  years of related occupational experience in the discipline; or, college work, military training, or nationally recognized
  certifications equivalent to an Associate's degree plus six years of occupational experience related to the discipline,
  OR
- Eight years of experience in the manufacturing and design occupation, two years of which must have included assignment as a supervisor, instructor, trainer, or owner of an aircraft maintenance facility.
- Antelope Valley College Equivalency: No current equivalency

<u>AND</u> Sensitivity to and understanding of the diverse academic, socioeconomic, cultural, disability, and ethnic background of community college students.

## Desirable Qualifications:

- Advanced knowledge of part creation, assembly, and drawings within the following 3D CAD programs
  - Solidworks and/or CATIA / 3DExperience
- Advanced knowledge of CAM toolpath development within the following programs
  - Fusion 360, Solidworks, and/or CATIA / 3DExperience
- Advanced knowledge of CNC mills, CNC lathes, CNC plasma cutters, laser cutters
  - Including programming, operation, tooling, and safety
- Ability and/or evidence related to developing training aids
- Ability to effectively communicate both orally and in writing
- Evidence of a commitment to teaching/learning and vision of a learning-centered institution and community
- An understanding of how technology can support learning and a record of support for technological advancements

# Duties:

- Instruct students in the assigned discipline
- Develop curriculum for courses
- Develop SOP (Standard Operating Procedures) for equipment
- Recommend purchase requests for materials and tooling
- Assignment may include teaching courses during the day, evening, and/or off-campus
- Ability to work close with industry partners

# APPLICATION PROCEDURE

To be considered an applicant for an Adjunct Faculty position in the Antelope Valley Community College District, all of the following documents must be submitted no later than 6:00 p.m. Monday through Thursday and 11:30 a.m. on Friday the deadline date.

## Required Application Materials:

- 1. A completed and signed Antelope Valley College Adjunct Faculty application
- 2. Resume
- 3. Transcripts of ALL college work (unofficial or copies accepted to begin file) that supports and substantiates the requirements of the position. Transcripts must include verification of degrees conferred.
- 4. Two letters of recommendation related to your professional experience (within one year)
- 5. California Community College Credential, if held (possession of a CCC credential is not required)
- 6. For those disciplines with established Academic Senate's approved equivalency; complete the Supplemental Equivalency Request form (if applicant is applying based on an equivalency and is requesting review, a blank form is provided with the application).

<u>Note:</u> Any degree from a country other than the United States, including Canada and Great Britain, must be evaluated by an evaluation service.
