Guided Pathways Committee Term Limits	Nate Dillon	 Michele Lathrop was listed as Academic Affairs, but is not in an Academic Affairs position, so she was moved to Student Service position with Wade Saari. A CMS Academic Affairs position was created, and Sam Darby was given the position. It was decided to make this position a standing appointment moving forward. Monica Carreon will no longer be representing the State Guided Pathways Committee, so that position will be removed from the committee. It was decided to remove the Classified Academic Affairs position since the addition of Sam Darby as the CMS Academic Affairs representative. It was decided to make the IERP role a standing appointment. It was decided to stagger the terms so that half the committee would start a 2 ½ year term in Spring 2022 and the other half would start a 3 ½ year term. Then following the end of those terms, everyone would continue with 3 year terms, and the positions would remain staggered. We made the decision by going down the position

Areas of Study Review

This Fall, the AVC Guided Pathways Coordinating Committee (GPCC) designated a workgroup (GPW) to review the Areas of Study and refine them if needed. The attached document proposed by GPW has been vetted by the group of counselors, ASO, and deans and was endorsed with a unanimous vote by GPCC at its October 2021 meeting.

Notes:

- The name for each area of study is a placeholder and may change pending a discussion with the larger campus community. At this juncture, GPCC is simply seeking an endorsement of the groupings of various areas of study in order to move forward with the revision of the catalog and the website redesign.
- Certain disciplines have been listed twice (and indicated with a double asterisk) as the group saw them fitting in more than one area of study. This does not mean that the discipline itself will be in two different divisions or departments.
- We have indicated disciplines which do not currently have a degree or certificate associated with them with one asterisk.
- While this list encompasses broad disciplines, not every program within those disciplines is listed. The intent is to link the disciplines through a drop down menu to various certificates/programs within them, as well as provide all the possible careers and Labor Market Data for each (Phases 2 and 3).

The following lists are suggested meta major groupings for the AVC campus. It is the result of collaborations with the Guided Pathways Committee's Meta Major Workgroup and campus stakeholders ranging from students, faculty and staff. After student surveys, we have decided to use the term "Areas of Study" on our campus when referring to meta majors. The Guided Pathways Committee is presenting this document as a further way to elicit feedback and communication from different stakeholder groups on campus. We are attempting to improve and clarify our groupings to allow students to better choose their plans of study at AVC. By grouping similar programs together, we hope to minimize the impact on a student's progress if they decide to stay within an Area of Study.

In this planning, it is important to make certain distinctions so that students may take the least number of units prior to transferring or receiving their certificate or degree, so clarification is essential. For example, under **Accounting**, the AA degree that a student would receive is **Professional Bookkeeping**. This is not the appropriate course of study for students wishing to earn a bachelor's degree in **Accounting** (a student taking this course of study will take **30** additional units before transferring to a university). Another example is, under Education, the degree the student will receive is an **AA in Instructional Aide**. Students may unknowingly take this course of study in pursuit of a teaching credential (a student taking this course of study will take **20** additional units before transferring to a university). An **Instructional Aide AA** is not required for a credentialed teaching career.

Please help the Guided Pathways Committee in clarifying these distinctions and with any other feedback you may have regarding the groupings of programs within these suggested Areas of Study.

Areas of Study Review

This Fall, the AVC Guided Pathways Coordinating Committee (GPCC) designated a workgroup (GPW) to review the Areas of Study and refine them if needed. The attached document proposed by GPW has been vetted by the group of counselors, ASO, and deans and was endorsed with a unanimous vote by GPCC at its October 2021 meeting.

Notes:

- The name for each area of study is a placeholder and may change pending a discussion with the larger campus community. At this juncture, GPCC is simply seeking an endorsement of the groupings of various areas of study in order to move forward with the revision of the catalog and the website redesign.
- Certain disciplines have been listed twice (and indicated with a double asterisk) as the group saw them fitting in more than one area of study. This does not mean that the discipline itself will be in two different divisions or departments.
- We have indicated disciplines which do not currently have a degree or certificate associated with them with one asterisk.
- While this list encompasses broad disciplines, not every program within those disciplines is listed. The intent is to link the disciplines through a drop down menu to various certificates/programs within them, as well as provide all the possible careers and Labor Market Data for each (Phases 2 and 3).

The following lists are suggested meta major groupings for the AVC campus. It is the result of collaborations with the Guided Pathways Committee's Meta Major Workgroup and campus stakeholders ranging from students, faculty and staff. After student surveys, we have decided to use the term "Areas of Study" on our campus when referring to meta majors. The Guided Pathways Committee is presenting this document as a further way to elicit feedback and communication from different stakeholder groups on campus. We are attempting to improve and clarify our groupings to allow students to better choose their plans of study at AVC. By grouping similar programs together, we hope to minimize the impact on a student's progress if they decide to stay within an Area of Study.

In this planning, it is important to make certain distinctions so that students may take the least number of units prior to transferring or receiving their certificate or degree, so clarification is essential. For example, under **Accounting**, the AA degree that a student would receive is **Professional Bookkeeping**. This is not the appropriate course of study for students wishing to earn a bachelor's degree in **Accounting** (a student taking this course of study will take **30** additional units before transferring to a university). Another example is, under Education, the degree the student will receive is an **AA in Instructional Aide**. Students may unknowingly take this course of study in pursuit of a teaching credential (a student taking this course of study will take **20** additional units before transferring to a university). An **Instructional Aide AA** is not required for a credentialed teaching career.

Please help the Guided Pathways Committee in clarifying these distinctions and with any other feedback you may have regarding the groupings of programs within these suggested Areas of Study.

1. Please provide an update on the progress of your workplan.

Areas of Study have been decided upon and are awaiting naming based on student survey results. Recommended Pathways, which include specific recommended GE classes have been created and are available in the campus catalogue. The campus website redesign is in full development, with plans of completion in spring 2022. We have implemented CCCMyPath as our new

primary onboarding system for new students and hope to utilize it to keep in touch with these students throughout their time at AVC. The implementation of EduNav is continuing, which will be a helpful tool in student course planning. The development of Smart Schedules prescribed course sequences mapped to 2-year completion, are being developed for many programs on campus; Smart Schedules are organized with course scheduling to assure the class sections will be available at the appropriate times for students and do not conflict/overlap. Our new Mentor & Match system is being implemented to match faculty and staff with students who wish more one-on-one guidance in their schooling.

3. If you would like to provide clarification for this percentage, please answer below:

Since Guided Pathways has updated most campus programs to include Recommended Pathways, nearly all students engage in Guided Pathways practices. Guided Pathways has also helped to implement our new CCCMyPath onboarding system, so nearly all new students are engaged with Guided Pathways from the moment they begin to apply to the campus.

4. What has the college done to align course offerings with student education plans?

We have started the creation of Smart Schedules which are coordinated with the scheduling of course offerings in their according discipline areas to ensure that students who follow their designated Smart Schedule receive the classes they need at the appropriate times and that their essential courses do not conflict.

5. Please provide one major success of your college.

The inclusion of specific recommended GE classes for our programs in their Recommended Pathways has helped to guide students through the confusion of the selection process. The creation of Smart Schedules will help guide students to an on-time completion of their programs.

7. Please provide any additional information you feel would be helpful based on your selection above.

CCCMyPath has been an excellent resource for our new students. Making software like EduNav available and maintained by the Chancellor's Office would be extremely helpful. It would also allow for easier articulation between campuses in the CCC network if it were organized on a cross-campus level. Campuses are having to individually enter transfer/articulation information at each site, but if there were one EduNav-type network it would help students in moving from one campus to another and provide course planning and support for students at all CCC campuses.

8. Please provide one major obstacle for your college.

Our campus has had difficultly in coordinating the scheduling of course offerings so that students can complete their educational goals in a timely manner. After investigating several programs, it was discovered several of them scheduled classes in a way that made it impossible, or nearly impossible, for students to graduate on time, due to unavailability and conflicts of required classes.
