Students applying for the AFMT program must complete all prerequisites by the end of the spring term for fall admission. A new cohort is admitted annually in the fall. Please note that submission of an application does not guarantee admission to the program.

**AFMT Program Prerequisites:**

- Completion of the Aircraft Fabrication & Assembly Technician (AFAB) **or** Aeronautical and Aviation Technology associate degree/course sequence.
- Completion of the general education/lower-division prerequisites listed on the next page (section C).
- A minimum GPA of 3.0 in all AFAB/AERO courses **and** 3.0 in all college courses taken for credit (overall GPA).

Note: General education and lower-division elective credit will only be accepted from regionally accredited colleges or universities.

**Application Process:**

1. Complete an Application for Enrollment form.
2. Complete the AFMT Rubric - Student Questionnaire form.
3. Attach official college transcripts for all post-secondary institutions attended, including Antelope Valley College. If you have Advance Placement (AP) credits, an official AP Score Report must be on file with the AVC transcript office. "Official" college transcripts must be submitted in a sealed envelope that has not been opened by the student.
  - One set of transcripts is to be turned in with your application and one set must also be on file with the AVC transcript office.
4. Attach a copy of your updated Education Plan completed by one of the listed AVC Counselors or Advisors assigned to the AFMT program (see list below). Appointments should only be made with the assigned personnel listed below. 5. Submit items 1 through 4 to the Aerospace, Industrial Arts, & Applied Technologies division office, Enterprise Lab, Room 136. Items 1 through 4 are considered your "application packet". You may also mail your application packet to: Antelope Valley College, Attn: Rosie Heasley, 3041 W. Avenue K, Lancaster, CA 93536. An after-hours drop box is located outside of EL-136 for application submissions; however, late applications will not be considered for admission.

Students are advised of eligibility to enroll in AFMT program by email. Students not admitted need to reapply the following year. **Incomplete packets will not be considered.**
