Higher education institutions have been under increasing pressure to account for the quality of their degrees. Five concrete guidelines illustrate how students should perform at progressively more challenging levels. Demonstrated achievement in performing at these ascending levels creates the grounds on which degrees should be awarded. These guidelines describe five basic areas of learning: Broad, integrative knowledge; specialized knowledge; intellectual skills, applied learning, and civic learning. AA-T and AS-T will be the 1st degrees to develop program learning outcomes based on these five areas of learning.
