Declarations of Candidacy for eligible candidates desiring to file may be obtained from the Elections Office, 1115 Truxtun Avenue, Bakersfield, commencing on July 16, 2018, 113 days before the election, and shall be filed with the Elections Office no later than 5:00 p.m., August 10, 2018, the 88th day before the election. The Elections Office will also be open for candidate filing Saturday, July 28, 2018 and Saturday, August 4, 2018 from 9:00am to 2:00pm.

IN ADDITION, Declarations of Candidacy papers may be obtained at the Mojave Administration Building, 1775 Highway 58, Mojave, on July 24, 2018 and July 31, 2018 between the hours of 9:00 a.m. to 12:00 p.m. and 1:00 p.m. to 4:00 p.m. or at the Ridgecrest Administration Building, 400 N. China Lake Blvd, Ridgecrest, on July 26, 2018 and August 2, 2018 between the hours of 9:00 a.m. to 12:00 p.m. and 1:00 p.m. to 4:00 p.m.

Current law requires all candidates to file a Statement of Economic Interest (Form 700) with the county elections office where they file their declaration of candidacy. These forms are due no later than the final filing date for the declaration of candidacy. The form can be found on the FPPC website (www.fppc.ca.gov), or is available at the Elections Office. In the event there are no nominees or an insufficient number of nominees for each office and a petition for an election is not timely filed, an appointment to such office shall be made pursuant to Elections Code Section 10515.

Each candidate for nonpartisan elective office may prepare a Candidate's Statement pursuant to Section 13307 of the Elections Code. Such statements may include the name, age, and occupation of the candidate and a brief description of no more than 200 words of the candidate's education and qualifications expressed by the candidate. Each statement shall be

included in the Sample Ballot, which is mailed to each voter.

Each candidate filing a statement will be required to pay in advance their pro rata share as a condition of having their statement included in the Sample Ballot.
