VI. Discussion Items	 A. POCR Update (Norming Meeting) – Perry Jehlicka - Hoping to have it approved and ready to go by the end of this semester. This will help us with the CVC making us an approved POCR campus. B. AVC Online Update – Perry Jehlicka/Alex Parisky - Perry, Alex, Dr. Beyer and Dean Bormann have been working a lot on this lately. Is there an amount that would be too much or overkill? Lots of very good research and info out there for both faculty and students. Hoping that it could be finished by next week.

	D. Presentation – Honorlock – Online Proctoring - Discussion: ASO believes that Honorlock should not be used by AVC. The ASO Rep, Oscar, shared the document that ASO has created with reasoning behind why Honorlock should not be used. Mary Jacobs responded - in Nursing using a proctoring site has drastically helped both their faculty and staff. She thinks this should be something AVC should consider. ASO says that the 360 scans of the rooms is intrusive and creates extra stress for the students. Constantly being watched causes high anxiety for students. Having to stand/sit still through an entire test is restricting and detrimental for the students. He would like to see if AVC can find a proctoring site that doesn't rely on the camera. Many students don't have cameras on their computers. Per Alex, the camera/monitoring the students option is very wide spread on lots of proctoring programs. The ASO believes that students will find ways to cheat or to foil the system regardless. Mary said that Honorlock is much easier to use, much more user friendly and better features. And with Nursing, they have to have a way of proctoring exams with online courses. May - family lives play a big role (especially with our students) in whether the student turns on their camera or not. Due to low income, abusive family, etc. Is there a compromise we can come to? Dr. Ken Lee teaches public speaking, so cameras are necessary. Should it be something that the faculty can work with each class on? Perry - this has been a topic of discussion for a while. Mary - can we test it in a couple classes and see how it
