#### 1. CALL TO ORDER AND ROLL CALL

The Faculty Professional Development (FPD) Committee meeting of September 10, 2014 was called to order at 2:04 p.m. by Dr. Irit Gat, Chair.

#### 2. OPENING COMMENTS FROM THE CHAIR

- Dr. Irit Gat welcomed members to the first meeting of the academic year. She thanked Mr. Mark Hoffer and Ms. Nancy Masters for their assistance with the creation of the 2014-2015 FPD Handbook, which due to technical glitches did not reflect Mr. Hoffer's input. Dr. Gat reported the 2015-2016 FPD Handbook will be an online resource only. Individuals who would like a hardcopy will be able to print one from the online calendar. She noted the decision to produce the resource online will save time and money, allow for easy revision, eliminate confusion with an outdated hard copy, and help the environment.
- Dr. Gat reported receiving an email from the Chancellor regarding Assembly Bill No. 2558 part of the Student Success initiative, has advanced to the governor's desk. If signed the recommendations and mandates will begin in 2015.

#### 3. OPEN COMMENTS FROM THE PUBLIC

Ms. Kathryn Mitchell brought the following to the committee's attention:

- President Knudson has said incorrect statements and misrepresented what the FPD Committee formerly did. President Knudson stated the former FPD Committee docked pay, a reason management of the FPD plans/contracts was moving to the Deans. Ms. Mitchell explained the committee reported missing hours to the Vice President of Academic Affairs, who in turn made the request for the pay to be docked, not the committee. Ms. Mitchell clarified the committee never did anything outside of the committee job description.
- Ms. Mitchell stated under the Chancellor's guidelines the plans/contracts must be reviewed by peers. The Deans as administrators are not peers, and therefore are not to review plans/contracts.
- Ms. Mitchell noted the Chancellor's guidelines state there should be adequate support, equipment and supplies to accomplish the necessary requirement of the program, and since the Senate Coordinator had moved to the President's office, can no longer support the committee. She explained the FPD program is entitled to clerical support.

#### 4. APPROVAL OF MINUTES

 May 14, 2014 Faculty Professional Development (FPD) Committee Meeting Minutes (attachment)
 A motion was made and seconded to approve minutes of the May 14, 2014 Faculty Professional Development Committee meeting. Motion carried with two (2) abstentions.

#### 5. INFORMATIONAL ITEMS

- a. Welcome and Introductions Dr. Gat welcomed members and led self-introductions.

  Dr. Gat reviewed and led discussion of FPD Committee Ground Rules and Duties see attachment. Mr. Mark Hoffer will send his recommendations for language to Dr. Gat for publication on the website.

#### 6. DISCUSSION ITEMS

- New FPD Online Plan/Contract Reporting System Greg Krynen
  Dr. Gat led discussion regarding the new online FPD reporting system. She encouraged members to thank President Knudson, Greg Krynen, Stephen Burns, Rick Shaw and Dr. Ed Beyer for their hard work and contributions in development of the new program.
- b. New FPD Reporting System: FPD Committee Role, Deans Role Dr. Bonnie Suderman (attachment)

Dr. Bonnie Suderman addressed members to explain the reason management of FPD plans/contracts has moved to the Deans, and also responded to Ms. Kathryn Mitchell's comments. Dr. Suderman explained per the California Education Code, any assignment of work must be given by an administrator, not by faculty (peers). It is against the Education Code for faculty to assign work to other faculty. By having plans/contracts reviewed and approved by the Deans, the district maintains compliance, as the FPD work gets paid or sick time is docked. Faculty professional development activity is managed by Deans or administrators across community colleges throughout the state. The district has been out of compliance in allowing faculty to approve the plans and contracts.

Dr. Suderman explained the Administrative Assistants in each area were given training for the new FPD reporting process, for a general knowledge to assist faculty that may walk in with questions. The Deans had a more in-depth training of the Faculty Professional Development program, including standards and the new online reporting process. Deans will also be trained on gray areas within the standards.

Dr. Suderman reported Ms. Masters has and will continue to provide assistance with flex questions. It was noted Ms. Masters remains the Senate Coordinator and provides 100% support to the Academic Senate. Her title has not changed – only room assignment. Her support to the FPD Committee has not changed. Dr. Suderman and Dr. Gat explained committee members can also serve as liaisons to provide assistance with FPD questions.

Members discussed the peer review guidelines as outlined by the Chancellor. Dr. Suderman reiterated the plans/contracts are an assignment of work and are legal contracts tied to pay. As such, the work must be reviewed and approved by an administrator. Dr. Suderman distinguished guidelines as strong suggestions that when contrary to Title 5 and the Education Code, will always be superseded. Members wondered, if the language of Title 5 and the Education Code had not recently changed, why the issue was being addressed now, and if FPD program practices had truly been out of compliance through numerous Accreditation cycles, or if Administration was simply interpreting Title 5 and Education Code in a new way.

Members considered whether overworked Deans will place the duty of reviewing and approving contracts on their administrative assistants. Mr. Greg Krynen informed the committee the assistants do not have access to the online systems, and Deans will not share login rights nor transfer duties.

Dr. Gat addressed Ms. Mitchell's comments, and reported she spoke with Ms. Leslie Carr, Director of Professional Development for College of the Canyons, and also sought direction from LeBaron Woodyard, Dean, California Community Colleges (CCC), Chancellor's office. Dr. Gat explained the Chancellor's Guidelines are simply guidelines – not mandates and are not Title 5. Colleges are given expressive flexibility within the said guidelines.

Dr. Tom O'Neil reported he has approved several plans/contracts without issue. He added Dr. Les Uhazy has approved dozens of plans/contracts without issue.

Mr. Greg Krynen reported 178 contracts have been approved, with 200 more in working/saved status before the September 15 deadline. Mr. Krynen stated outside of 20 faculty members who made errors, the new program is running smoothly. He noted Dr. Louis Lucero communicated great appreciation for the new reporting system, the ease of function, and for the FPD Handbook that is 100% ADA compliant, adding '*Great for a new program.*'

Members addressed the concern that, while the Deans are reviewing plans and contracts electronically, there needs to be a link between the electronic reporting system and the hard copy attendance of sign-in sheets. Additional clerical support for the committee was suggested.

Members voiced concern the reporting system happened at the tail end of a semester and during summer without the committee weighing in. It was noted President Knudson addressed the Senate in May 2014 regarding changes during summer, to include streamlining the reporting system. Dr. Suderman explained an urgency to bring the district into compliance in the reporting structure, happened during summer.

Members addressed a concern of the reduction of the committee's duties. Dr. Gat stated to the contrary, the time formerly spent reviewing plans and contracts, can now be redirected to building the program. Dr. Suderman complimented the committee on such an inspirational and outstanding program, but noted the tremendous time and effort necessary to produce the program in a high level of expertise. She explained when the President identified non-compliance, correction came quickly during summer, and management of FPD contracts was moved to the Deans. Instead of burdening Deans with paper products, the President elected to work with Greg Krynen and Dr. Gat to create a system online.

It was noted streamlining the reporting and other FPD processes has been discussed about in numerous meetings, and was discussion in Senate meetings in May 2014.

Members identified the need for better communication. Members readdressed the spring 2014 survey seeking faculty opinion regarding professional development obligations. Some suggested town hall meetings as discussed last year.

Members expressed frustration in the quality, funding and opportunities in the FPD program that have diminished compared to several years ago. Dr. Suderman will ask President Knudson about possible funding. Dr. Gat noted Assembly Bill 2558 is on the Governor's desk, and if signed, will release funds to support professional development.

Dr. Gat will meet with President Knudson to discuss the aforementioned concerns.

c. 2014-2015 FPD Committee Goals (attachment)

Dr. Gat reviewed and led discussion regarding 2014-2014 FPD Committee Goals – see attachment. She encouraged members to contribute to the list. Dr. Gat shared Dr. Beyer's suggestion to focus on a few goals to bring to fruition within a year or two, separate from ongoing goals.

Dr. Gat raised the issue of simplifying the FPD program and process. Even though the standards have been used for many years, there is a perception among some faculty that they are confusing and that the handbook is confusing, resulting in numerous emails and calls to the Chair and Senate Office. Dr. Gat pointed out that some faculty members do not take the time to look at the handbook. Dr. Gat noted that streamlining the program will not diminish it, but simplification of the process is advisable and will make the program more efficient. It was suggested that the committee approach the standard structure from a philosophical standpoint to determine the point of each standard.

Dr. Gat suggested faculty have more of a voice in where they want professional development. Many faculty feel professional development is a burden when it should be a joy. She wishes to first address the four (4) standards.

It was suggested a town hall meeting might be premature, and consideration of a task force was suggested to compare what types of professional development programs and obligations are in place on other campuses.

Dr. Gat was approached by Dr. Suderman regarding the spring 2014 survey regarding the FPD obligation. Dr. Gat will invite Dr. Ed Beyer and Dr. Susan Lowry to participate in that discussion.

- Dr. Gat led discussion regarding gray areas within the standards, and has identified an ongoing list to identify these areas.






# Q5 What days would best suit your schedule for attending FPD events?
