COVID-19 & Honors Convocation	<ul> <li>Discussed the Subject Area Awards Process and what creative ideas we might implement to still celebrate the students and their culmination of the Honors Program Experience.</li> <li>New deadline for Subject Area Awards- May 1<sup>st</sup></li> <li>In light of most Admin Assistants being unavailable- we will need committee assistance to get through the nomination process. John and Mark offered to assist. We will need more assistance in vetting all nominations.</li> <li>Committee discussed sending Grad Lists and Subject Area Award Memos directly to the Deans, and having the Deans serve as the</li> </ul>

They will not be able to distribute the Grad Lists, but can discuss graduating students with their faculty to give them ideas for nominations.</li> <li>Ideas included: Moving the Honors Convocation to fall 2020. Vejea will reach out to Dr. Z to discuss commencement software that may be used for commencement 2020. Mailing Subject Areas Awards to students with video messages from nominating faculty.</li> <li>Action – Co-Coordinators will distribute Grad Lists to Deans, and Nancy will work with Deans to put names into the Subject Area Award spreadsheet.</li> <li>Guests were thanked for their contributions and invited to leave the meeting.</li> </ul>
VI. Honors (TAP) criteria	<ul> <li>Currently we require:</li> <li>3.25 GPA</li> <li>6 Honors courses (3 of which must be actual Honors courses)</li> <li>Impact of current requirements – fewer students are able to enter and complete the program</li> <li>Creates inequity for student who may be first generation or disadvantaged – limits the students who can benefit from a Transfer Alliance Program agreements (Honors 2 Honors) brokered by the Honors Transfer Council of California.</li> <li><b>Discussion:</b> General consensus was that in light of the Honors 2 Honors transfer requirements, we should adjust our standards to provide more access for AVC students. Overall, the committee was is favor of reducing the number of required honors units to 15 (standard for Honors 2 Honors agreements), and changing the GPA requirement to 3.0.</li> <li>Areas of concern – many committee members are in favor of the 15-unit honors course requirement, as long as 3 actual honors courses are still required. Those who felt strongly included John, Susan, and Rae. Our Student Rep, Jahlen, expressed how difficult it is for students to complete 3 actual classes, and that this requirement may result in students not being able to complete the program requirements. Those in favor of keeping 3 actual Honors courses, feel strongly that these courses provide a unique and robust experience that will keep students engaged and better prepare them for university.</li> <li>There is also concern voiced by many, that there is little regulation over what constitutes an Honors Option, and therefore no accountability for Honors Option faculty.</li> <li>This discussion will be continued at the next regular meeting 4/27/20. Action will be taken at that time.</li> </ul>

	<ul> <li>Reviewed Proposal: General enthusiasm for the Epigenetics Option. Lots of discussion regarding the fact that many students will find out "bad news." Prof. Thibault answered this well an discussed how students learning this information can shape their behavior in a more positive way, to change the outcomes for future generations. Discussion concerning adoption and Prof. Thibault has an alternative way of completing the Option where students will just investigate topic related to themselves only. Students will be required to complete both a paper and presentation, and there was concern regarding the absence of a page number range for the paper. The general consensus was that the students will need a hard number, Prof. Thibault agreed to add this component.</li> <li>Action- Vote taken and the proposal was approved unanimously.</li> </ul>
VII. Honors Option Proposal	<ul> <li>Fritz Hemker – POLS 203 (proxy for presentation – John Vento)</li> <li>Reviewed Proposal: Well received by the committee. There was a lot of excitement about investigating the limitations of the judicial branch. Students will complete both a paper and presentation. Concern over the length of the paper (10-12 pages). The general consensus was this was too long. John agreed to speak with Hemker and have the length reduced to 4-6 pages.</li> <li>Action- Vote taken and the proposal was approved unanimously.</li> </ul>
