The meeting was called to order at 3:00pm.

The minutes of October 6 were approved.

Reports

- a. Weave
 - Responses to the last two questions on the 2013 annual reports in WEAVE have disappeared. Meeta contacted WEAVE and will work with WEAVE to restore that material before moving copies of the 2013 reports to the program review website.
 - Stacey noted that one question on the template was not included in the WEAVE version and said there were other discrepancies with the approved 2014 template.
- b. SPBC and program review
 - The president wants to announce faculty openings in the Dec *Chronicle* which means SPBC will need to make those decisions in Nov. The current program review report deadline of Oct 31 creates urgency for the Committee's prompt review of 2014 reports. Committee members will strive to review all reports before SPBC begins budget work in Jan/Feb. Report deadlines and/or SPBC planning dates need to be coordinated before the next planning cycle. SPBC will probably be split into two groups, one for planning and one for budgeting, by the end of the month.

Discussion items

- a. PR templates and data elements
 - Several members of the committee expressed their concerns about the accuracy of the data on the Program Review website while others shared problems finding/calculating their data. Meeta said she and Svetlana will continue to seek ways to improve data reliability and use. She noted that much of AVC's data is entered by student workers and other people with limited training. We might be able to use filters to help automate data access next year. Some people noted that changing data parameters or using new data would prevent direct data comparisons but Ann noted that you will still be able to see trends. Meeta and Carol are asking writers to identify issues in their reports and use what data they can to keep the process moving along. Meeta

wants to use the simplest data needed. The committee will review data needs for 2015 reviews during the spring semester.

- b. 2014 reports status
 - Carol shared which programs have submitted comprehensive and annual reports. She noted that approximately half of annual update report writers have selected the status quo option. Emails have been sent to the President, deans, directors and lead writers reminding them to finalize their 2014 reports.
- c. 2014 reports evaluating 2014 comprehensive reports
 - The Library and Financial Aid Office reports have been submitted
