Dr. Ed Beyer, Academic Senate President and Dr. Meeta Goel, Dean of Institutional Effectiveness, Research and Planning, called the meeting to order at 2:41 pm.

Dr. Goel commented on several negative comments she heard about SPBC, such as:

- 'SPBC is broken' (it was announced at a meeting she attended)

She reminded the group about a statement that Dr. Beyer made at a prior SPBC meeting, 'comparing the meetings to now, from over a year ago, the meetings has changed so much for the better, and how everyone is laughing and getting along.' She explained that when she hears the same negative tape being played from over a year or 2 ago, it gets old. Especially when the people making these comments don't attend the SPBC meetings. Dr. Goel asked everyone to help by taking information back to the groups they represent or lead.

She continued to explain that once you implement your EMP and the President's goals, and get some results from your actions: missions are about actions. The vision is about desire: the desire to act going down and the results feeds up and then you tweet your visions, missions, and values again, based on your results. The vision is the 'why', the mission is the 'what and how'

The Superintendent/President may recommend budget expenditures to the Board of Trustees without consensus of the BC in those instances of legal and fiscal responsibility, as cited in both Education Code and Title 5. The Superintendent/President submits budget recommendations to the Board of Trustees for approval.

## WHAT IS A VISION STATEMENT?

- Desired end state or long-term desire
- > Ideal future state
- It is inspirational
- A shared purpose, dream for the organization
- Informs/guides internal and external constituents
- Helps the organization focus on what is most important

## More Specifically, a Good Vision Statement:

- Answers the questions: Why do we exist? Are we working on the right thing? What do we intend to be?
- ➤ Is concise: A single phrase or sentence (about 10-15 words) that clearly explains what AVC is trying to accomplish in the future
- Is specific, but not so specific that it will not be applicable in a year or two (it has broad applications)
- Is easy to understand and communicate
