# What did your committee accomplish to further the College Mission?

Accomplishments: The Safety Committee has helped to maintain a safe and healthful learning and working environment for students, employees and visitors by maintaining a free exchange of information and ideas relating to health and safety at the District's 3 locations among the students, faculty and staff. This exchange of information and ideas helps facilitate an environment as free of hazards as is practicable under due diligence as well as mitigation of those hazardous conditions and actions that may be identified but that cannot be immediately eliminated. By eliminating and mitigating hazards, the losses that would otherwise occur are precluded and the cumulative result is a more effective institution.

# What did your committee accomplish to further the 2019/2020 College Goals?

**Goal 1:** Continue arranging, and mount at First Aid Kit/tourniquet locations additional containers or dispensers of commercially-prepared packages of gauze that has been impregnated with a hemostatic agent for wound packing to quickly control severe bleeding.

**Accomplishments:** These materials have been placed in the AED cabinets at all 3 District locations. This goal has been met.

Goal 2: Continue arranging 4-hour CPR/AED & First Aid Classes on campus for Full-Time Employees.

**Accomplishments:** Progress on Goal II was interrupted by the COVID-19 pandemic. Prior to the interruption, 23 full-time employees received instruction in CPR/AED. We will resume pursuit of the goal when conditions permit.

**Goal 3:** Continue increasing the identification and mitigation of slip, trip and fall hazards at all District locations.

Accomplishments: Maintenance & Operations personnel continued to maintain a heightened level of alertness to these conditions and addressed them when detected. The Safety Committee Members heightened the awareness of their constituencies by distributing examples of these conditions in the form of photos with descriptions from Quarterly Safety Inspection findings. This serves to educate constituency members on conditions to be on the look-out for and to report if and when seen so that the hazards can be eliminated. This goal has been met.

# LANCASTER MAIN CAMPUS

Location: Health and Science Room 161 (Photo 1)

**Recommendation:** No recommendation at this time. The site uses a well-placed Keenan SafeSchools QR poster to share chemical information with building occupants.

**Location:** Health and Science Room 276 (Photo 2)

**Recommendation:** No recommendation at this time. Although the classroom was locked, the room did not have any obvious hazards.

**Location:** Health and Science south exit (Photo 3)

**Recommendation:** No recommendation at this time. Well placed campus evacuation map. The emergency procedure booklet is open to wheelchair evacuation instruction and posted directly across from the device.

Location: Health and Science south exit (Photo 4)

**Recommendation:** No recommendation at this time. The campus has several areas in various stages of construction with limited pedestrian access.

Location: Fine Arts rear exit (Photo 5)

**Recommendation:** No recommendation at this time. The barriers installed on both sides of the brick wall is a recommendation from a prior inspection. The barrier is intended to prevent pedestrian injury as pedestrians step onto the path without looking. The pathway is frequently used by utility carts and pedestrians.

Location: Walkway between portables and Fine Arts front entrance (Photo 6) Recommendation: The damaged transition ramp creates a trip fall hazard. The ADA transition ramp is split and tends to separate when weight is applied on the opposite side. The site should consider placing the damaged ramp to reduce trip fall risk near the access ramp.

**Location:** The damaged irrigation sprinkler near the bookstore's loading area (Photo 7) **Recommendation:** The damaged irrigation system allows water waste and creates a slip fall hazard. The broken sprinkler should be replaced to stop water waste and allow the walkway to dry.

Location: Wooden pallets staged near bookstore loading area (Photo 8)

**Recommendation:** The practice of storing wood pallets near trees and exterior walls creates an arson opportunity. As recommended in prior inspections, bookstore personnel should consider storing wood pallets away from the building.

**Location:** SSV exterior stairs (Photo 9)

**Recommendation:** Damaged exterior front and back stairs create a trip fall hazard. The concrete steps have several cracks and large chips which create an uneven walking surface. The steps should be resurfaced or replaced to reduce pedestrian trip fall hazard.

**Location:** Fire lane near CDC play area (Photo 10)

**Recommendation:** The fire lane near the CDC building is also frequently used by pedestrians. Three large holes approximately 12" x 12" stretch across the fire lane and create a trip fall hazard. The holes should be covered to reduce the risk of pedestrian injuries.

**Location:** Facilities breakroom (Photo 11)

**Recommendation:** No recommendation at this time. The campus Injury Illness Prevention Plan (IIPP) and IIPP Covid-19 Addendum is posted and accessible for all occupants.

Location: Classroom Courtyard (Photo 12)

Recommendation: No hazards observed during this inspection.

Location: Instruction Lab (Photo 13)

Recommendation: No hazards observed during this inspection. Several small appliances are pending installation.

Location: Instruction Lab (Photo 14)

**Recommendation:** No hazards observed during this inspection. The vented workstation was not connected during this inspection. Once installed, the site should establish a maintenance schedule to regularly replace soiled filters and maintain supporting documentation.

Location: Instruction Lab utility sink (Photo 15)

**Recommendation:** No hazards observed during this inspection. The site should install signage advising intend use, ie (Water Only or No Chemical Dumping).

**Recommendation:** No hazards observed during this inspection. The area was under construction during this inspection. The site should install weather resistant permanent signage.

### PALMDALE CENTER

Location: Office 120 (Photo 16)

**Recommendation:** Excessive storage is an ideal environment for unwanted pests such as mice and insects. The site should encourage occupants to reduce office clutter as recommended in an effective Integrated Pest Management (IPM) program.

**Location:** Custodial Closet/Fire Riser (Photo 17)

**Recommendation:** Custodial supplies should not block access to fire riser or electrical panels. The site should encourage custodial staff to maintain clear access to all emergency equipment.

**Location:** Office 109 (Photo 18)

**Recommendation:** Keyboard and monitor placement is frequently linked to employee request for ergonomic evaluation. As noted in prior inspections, the site should provide recommendations for occupants to set up their workspace. Encourage occupants to take a proactive approach foe ergonomic comfort.

Location: Office 109 (Photo 19)

Recommendation: Secure bookcase. Unsecured bookcases create a risk for tip over during seismic activity.

Location: Science Chemical Preparation Fume Hood (Photo 20)

**Recommendation:** No hazards observed during this inspection. The fume hood alarm was sounding during this inspection; however, there was no obvious hazard visible. During a prior inspection, the lab attendant stated he was not aware of the campus chemical hygiene plan. The lab should have a current copy of the campus chemical hygiene plan accessible to all lab technicians.

**Recommendation:** Although the eye wash station is accessible, the inspection sticker does not show regular inspection. The site should establish a schedule for regular inspection with supporting documentation.

Recommendation: No hazards observed during this inspection. The location is still under

construction, opening date to be determined.
