

## Why give TO ANTELOPE VALLEY COLLEGE?

Since our founding in 1929, students have come to AVC to pursue their dreams and transform their lives. Antelope Valley College each year draws thousands of students from 20 separate communities and nearly 2,000 square miles. Though 65% of community college students are the first in their families to pursue a degree, California community colleges train 80% of firefighters and police, 70% of nurses, and a wide margin of university transfers.

Our students illuminate the past, shape the present and discover the future. Yet, the dream of completing a college education is out of reach for many. It is estimated almost half of all California community college students have no way to pay for the rising cost of their education. As such, only three out of every 10 students achieve the most basic goals of earning a two-year degree or transferring to a four-year university.

Our campus faces an ever-increasing demand for the best in high-quality, WASC-accredited, low-cost education. But we will likely receive fewer state dollars than ever each year to meet that demand. Giving to AVC through the foundation helps fund needed student scholarships and campus grants to bridge that gap, improving the quality of our college and our community as a whole.

## ON RECEIVING AN AVC FOUNDATION scholarship


#### Jaquine James, AVC Criminal Justice student
