 - ii. American Honors, Inc. is actively calling college presidents to circumvent senate, also calling state legislators to change laws
 - 1. Legally it seems they can't be involved with California colleges yet
 - iii. The committee was presented a resolution by the state Academic Senate against companies like this
 - The committee was asked how it felt about this and if they would support AVC working to keep such companies out of the honors program
 - b. Spring Class list
 - i. The list for Spring 2016 honors classes was presented to the committee
 - 1. Mr. Vento asked members for any comments or questions

- 2. Committee was favorable toward the amount of classes and diversity of subjects
- c. Honors poster
 - i. A recruiting poster for the Honors Program was presented to the committee.

 - 1. Other thoughts were

 - i. The Honors Program needs to survey students about the classes and professors
 - ii. A sample has been produced, but needs be to revised a bit before the committee takes action
 - iii. The survey should help to provide data to support needs for the Honors Program
 - iv. When ready, it will be administered via a web service like Survey Monkey
