The Associate in Science in Administration of Justice for Transfer (AS-T in Administration of Justice) degree at involves the study of the theory and practice of law enforcement, police work, the court and corrections systems. Law enforcement, whether as a line police officer, deputy sheriff, marshal, or state traffic officer, offers a rewarding opportunity to serve society. Specialized officers such as game wardens, forest rangers, or criminal investigators make unique contributions throughout our state and nation. They investigate crime, present cases in court and render other service to the justice system and the people. The Associate in Science in Administration of Justice for Transfer (AS-T in Administration of Justice) degree meets the requirements of SB 1440 for Associate Degrees for Transfer (ADT). Associate Degrees for Transfer are for seamless transfer to a CSU. To earn an Associate in Science in Administration of Justice) degree, a student must complete the following:

1. Completion of 60 semester units or 90 quarter units that are eligible for transfer to the California State University, including both of the following:

A. The Intersegmental General Education Transfer Curriculum (IGETC) or the California State

University General Education –Breadth Requirements.

B. A minimum of 18 semester units or 27 quarter units in a major or area of emphasis, as determined by the community college district.

2. Obtainment of a minimum grade point average of 2.0.

ADTs also require that students must earn a C or better in all courses required for the major or area of emphasis.
