## **Advisor's Report**

Dr. Zimmerman stated that at 3:30 p.m. the ballot was counted for the Senator Election, and there were a lot of write in candidates, and we'll contact those that are interested and eligible. Secretary Hux was present during the counting process.

Dr. Zimmerman had concerns about several issues and stated what she perceived to be the ASO's voice of the students and its roll and the roll of shared governance (students voice). Students years ago fought for this right to participate in the decision making process, and if the ASO doesn't participate they have no voice. She further stated that if an ASO member couldn't attend campus committee meetings an alternative should be assigned to attend these meetings. This semester there are a lot of things happening, such as what programs should be offered at the South Valley Site. Further she stated that she cannot attend shared governance committees for the students.

Dr. Zimmerman stated about the use of the ASO office. If the officers are not going to use the office she knows of a lot of faculty who would love to have this space, and how we should be in the office for students to contact the ASO. She further stated that the computers were for ASO use and not personal use and should only be used in regard to our duties. The computers in the office are not an open computer lab and violated campus policies, and that myspace.com isn't college related and that she has talked to individual members about myspace.com and the negative reflections on ASO.

Dr. Zimmerman stated that if the computer resources of the office are used inappropriately again, ASO email and the use of the computers will be removed it has been done before. The Florida conference is a good idea but what will you get from the trip? She asked that this item be put on the next agenda related to what we'll learn from the conference.
