VPCA Droutsas stated that it should not be tabled, that it was placed on the agenda for a reason, and it should be talked about now.

Secretary Hux said that the senators are not informed and it should be tabled.

In discussion; Senator Collins said she just assumed her position and would like time to hear the facts. Treasurer Ayres said everyone should say what needs to be said and get it out in the open. VPCA Droutsas said that in the past Secretary Hux had brought up a previous vote, and that personal issues should not be brought up. Senator Collins said that if the previous boards had voted on this then there must something to address. Maybe a committee should be formed or the Judicial Council should look into it. VPSS Ordonez said that he hasn't been shown anything and making decisions based on past votes is irresponsible. Mr. Don Lundy said that this is a deep subject and we need to wait on making a decision. Secretary Hux said that Dr. Zimmerman has failed to represent our voice, and does not do her job as advisor. She failed to give the candidates a draft of the student bill of rights for the board of trustees' forum. Dr. Zimmerman yells and screams regarding minutes and does not advise but controls. Treasurer Ayres said that she would like to know what a vote of no confidence is and what it would do, and why this appeared on the agenda with no warning beforehand.

At 3:03 VPCA Droutsas took a point of personal privilege to attend the AP&P meeting.

Ms. Hernandez said that the ASO advisor is a designation by the President of AVC. She would like for dialogue to happen when discrepancy come up, also Dr. Zimmerman should be present to defend herself. This is why we have open meeting discussions so that we get everything in the open so that President Scott can take our discrepancies to Dr. Fisher. Senator Collins would like to sit down with the facts and evaluate it. And that she wants to know where to find the education Code that states the designation of advisors. Also, this matter isn't personal, we all drop the ball; but it goes farther than

that. Third of all, we as a group should be educated on the proper protocol for this matter. An advisor should empower there students and lead them. Ms. Wilmot feels that this should be tabled until Dr. Zimmerman can be here to defend herself. Mr. Lundy asked how to bring up future issues, and if we are suppose to vote on issues that day. Can Dr. Zimmerman's role be modified, instead of complete removal?
