5.2 Overview of ASO Executive Officers position

ASO Officers should meet with their counterparts in Administration and other places they are needed. ASO Officers are also expected to attend meetings and committees as stated in the ASO By laws.

There are two branches of ASO, the Executive Council and the Judicial Council.

ASO had a learning session on what our goals are and why ASO is existent. ASO is the student representation organization. We must be careful of what we say and what we do as it may be reflective of ASO and the student of the college. ASO must also always keep their minimum requirements to stay in ASO. ASO is also a student advocate and lobbying organization.

There are two ways you can endorse actions, by referendum (vote of the people) and by resolution.

There are several types of meetings: Shared governance meetings and ad hoc or tasks force or conferences.

Shared governance meetings are state mandated and are sometimes advisory to the President of the college.

ASO Officers also must remember that they need state that they are representing the students of the college to assert their power.
