II. PUBLIC FORUM

Alex Horowitz spoke on behalf of the Model United Nations team here at AVC. He explained that the purpose of the class/club is to send delegates to conferences to compete as representatives of countries on various U.N. committees. Currently, the club is trying to raise funds to be able to attend a conference in Las Vegas at the Embassy Suites Hotel from November 22-25, 2008. The cost of the conference is \$6, 02.80, and the club is requesting \$4,000 from ASO in exchange for student education on the issue as well as advertisement. There are currently 20 students in the class/club.

III. PRESENTATION

AlertU - Guest Speaker - Mark Snyder, Interim Chief of Police

Mr. Snyder announced that AVC has purchased and begun utilizing a new emergency alert system that alerts those who sign up of any emergency that occurs on campus including but not limited to snow days, fires, violence, etc. He asked ASO if they could please sign up and advertise this around campus.

Dr. Zimmerman announced that the Chancellor's office purchased this for all 109 community colleges and that AVC NEEDS ASO to step in and advocate on student's behalf because currently, although we now have over 15,000 student on campus, only 500 have signed up for AlertU.

Additionally, Mr. Snyder announced that in a poll done in the last issue of the Examiner, it is apparent that the majority of students know next to nothing of emergency procedures. Therefore, he asked ASO to help make students aware of the posting that is up in all the classrooms about the emergency procedures and bulletins placed in any room about what to do in case of an emergency. VPAA Thomas asked if the monthly text tests that get sent out could contain advertisements of events on campus since it is essentially a wasted text, and Mr. Snyder, Dr. Zimmerman and Student Trustee Soos all stated that the texts should be kept for emergencies only in fear that people will disregard the texts if they turn in to nothing more than spam messages.

IV. ACTION ITEMS

4.1 ASO Committee Appointments

Dr. Zimmerman announced that next Wednesday the meeting will have to end at 8 am due to a presentation/discussion that will be held with students and the Strata Information Group in regards to how our ITS department is performing. As such, she asked if 2-3 people could please attend with President John Cabral. Student Trustee Soos and Senator of Social and Behavioral Sciences Smith both said they would be able to go. Senator of Visual and Performing Arts, Johnatan Olguin will also be attending as part of the Student Activities Council. The meeting will be held in A 141.

4.2 ASO Conferences

Senator of Instructional Resources, Ellis announced that she is the Region 6 chair and that the next meeting will be held in Santa Barbara on September 19, 2008 from 12-4 pm and that those who wish to go with her will be leaving at 9 am. President Cabral, Senator of Social and Behavioral Sciences Smith, and Senator of Instructional Resources, Ellis all plan to attend. The region is AVC's lobbying voice in Sacramento. Dr. Zimmerman announced that if an agenda is not posted up within 72 hours in accordance with Brown Act, then there can be no meeting

and therefore no one will be going. Upon looking to see how much money had been approved for the conference it became apparent that a motion was left out of the September 3, 2008 minutes.

Revisited September 3, 2008 minutes and edited them to include up to \$5,000 a year from the Student Representative Fee for all Region 6 meetings for the year as well as the cost of up to 8 people for attending the Student State Wide Student General Assembly October 24-26, 2008 as was moved by Senator of Instructional Resources, Ellis and seconded by Senator of health Science Douglass.

Moved to approve the September 3, 2008 minutes as edited made by Treasurer Blanton, seconded by Senator of Health Science Douglass. Motion passed 10/0/0.

Students to attend the Green Campus conference are VPAA Thomas plan to attend and possibly VPCA Sewell. Dr. Zimmerman is looking for an Advisor since she is unable to attend.

For the State Wide Student Senate General Assembly conference in October, Senator of Instructional Resources Ellis, VPAA Thomas, Senator of Health Science Douglass, Senator of Business, Computer Studies and Economic Development Theologidy and Senator of Counseling and Matriculation Walter all plan to attend.

Elijah Blanton called a Point of Personal Privilege at 7:59 am.

Quorum is 9, 10 members were present, Quorum is maintained.

4.3 ASO Activities

VPAA Thomas announced that greenjobs.org wanted to send representatives to the college to talk to businesses and students in the community about green jobs and that they would like a table on September 27th. Dr. Zimmerman stated that it sounded an awful lot like a job fair and that ASO is not currently equipped to take that on. She suggested that they should speak to someone in Job Placement and that there is a Job Fair being held on campus on October 15 that they should look into.

VPAA Thomas called a Point of Personal Privilege at 8:05 am.

Quorum is 9, 9 members were present, Quorum is maintained.

President Cabral asked members to sign up for the ice cream social in order to state their availability. Senator of Visual and Performing Arts Olguin, Senator of Social and Behavioral Sciences Smith, and President Cabral all planning on sending letters to vendors, with Senator of Visual and Performing Arts Olguin stating that if vendors are bringing samples that he/she needs to know about it as well as they need to bring their own tents.

Moved to approve up to a total of \$600 for the ice cream social by Senator of Social and Behavioral Sciences Smith, seconded by Senator of Visual and Performing Arts Olguin. Motion passed 9/0/0.

On October 14, 2008 at 7 pm ASO is hosting a 36th District Debate.

Moved to allocate up to \$200 for refreshments made by Senator of Health Science Douglass, seconded by Senator of Enrollment Services Wood. Motion passed 9/0/0.

Senator of Instructional Resources Ellis asked if there could be an AlertU week on campus and Dr. Zimmerman stated that she will see if a laptop could be found and set up so that students can sign up during the ice cream social.
