Liliah Jefery – From Image Gear USA - Her company is called Image Share. We currently have one shirt for one dollar that we sell. It is a nice quality polo shirt. The embroidery is really well done. There is no set up fee. We digitalize the image for free. We do screen printing. We also do digital printing. We have twenty colors to choose from. I will give you my business card. **Curtis Smith-** asked if is there a minimum order. **Liliah-** The minimum order is 12 shirts. **Curtis Smith-** asked if Image Share provide the shirts. **Liliah-** stated yes. **Dr. Zimmerman-** asked if Lilah indicated there is no set up fee for an order of a thousand shirts. **Liliah-** That is not for embroidered logo. That is for screen printing. That is for a thousand tee shirts. If you order a thousand tee shirts, there are no set up fees for screen printing. Embroidery is different. It depends on the stitch count. **Dr. Zimmerman-** asked what the turnaround time is- **Liliah-** it takes about 3 days to approve your logo. Once we receive your logo, we will email it to you for you approval. It then takes 3 to 4 days to embroider your logo.
