III. ACTION ITEMS

3.1 ASO and Committee Appointments

There was discussion of the Academic Senate and its meeting times.

Point of Personal Privilege, VPAA Shunnon Thomas, 8:15 am.

3.2 ASO Reorganization

Dr. Zimmerman- There are three interim deans: the dean of business, computer studies, and economic development, the dean of visual and performing arts, and the dean of language arts. That means they are only here for one year. The question is what will happen to those positions. Because of budget cuts, it has been decided that the college cannot afford them. The discussion is what we are going to do with those departments that will not have deans. The college is having a reorganization. Every constituency group- remember that ASO is a constituency group- has a vote. ASO has to vote where ASO fits within the organizational structure. ASO has fit within student services and student development for a long time. The question is: where does ASO best fit with the AVC structure. This is your opportunity to make a recommendation. You have to put that in writing and justify it. I have asked to every department that reports to me, as everyone else is asking every other department on campus. Those recommendations are forwarded to the vice presidents, and the vice presidents are forwarding those recommendations to the president, who is forwarding the recommendations to the Board of Trustees, who will then make a decision. This is prompted by academic affairs which has three interim vice deans. One of the ultimate goals is to get department chairs.

Elizabeth Soos- I don't think we fit anywhere else than where we are because Student Services is an umbrella and obviously we serve the students. **John Cabral**- I agree. **Timne Randolph**- If we were to fit anywhere else on campus, it would be Political Science because we are a governing agency and it would help us govern better. We are for the students, but we are a governing body. **Andrew Douglass**- We could easily fit under either one. **Elizabeth Soos**- That makes sense, but my concern with going under a particular department is that it would look preferential to the other departments.

There was discussion of whether ASO should remain under its current departments. Dr Zimmerman announced that recommendations for a change of department must be made no later than March 13, 2009.

Dr. Zimmerman- I am going to remind you what the Brown Act is. You cannot have discussions of agenda items outside of meetings that have quorum. I am just reminding you.

3.3 ASO Conferences

There was discussion of who would attend March on March. ASO had decided several weeks ago that ASO officers and two representatives per AVC club would be given attendance priority and then attendance would be open to all AVC students. This decision was not realized because communication issues prevented the informational email Senator Curtis Smith had prepared to be approved on time.

Dr. Zimmerman- Here is the problem. When you are having committee meetings that are not agendaized and meetings in the back, there are Brown Act violations with those decisions. **John Cabral**- We decided the deadlines for registration during a regular ASO meeting. **Dr. Zimmerman**- Did we just approve those minutes? **Timne Randolph**- No, it was the week before last.

There was discussion of extending the registration deadline to attend March on March to March 6, 2009 and informing AVC students about March on March before the deadline.

Moved to open attendance to March on March to AVC students with a registration deadline on March 6, 2009 by Senator Curtis Smith, seconded by VPCA Johnatan Olguin. Motion Passed 10/0/0

3.4 ASO and ICC Activities

There was discussion of money to be allotted to AVC Model U.N.

Moved to move \$1,000 from the Homecoming line item and \$500 from the Student Event line item into the Contingency line item so that ASO can allot \$1,500 to AVC Model U.N for their conference by Senator Curtis Smith, seconded by Senator Michaela Blidarescu. Motion passed 12/0/0.

Point of Personal Privilege, Senator Shannon Izquierdo, 9:20 am

President – I have heard a lot of concerns and misconceptions about accreditation. We need to make the students more aware that we are accredited and will continue to be accredited at least until 2010. We have received complaints about security. Some students have voiced that they do not feel safe. It is something that has to be discussed further. The school has new smoking policies. There will be new smoking areas. The enforcement of the new smoking policies will be an issue. ASO has to push for police officers to give tickets to people without parking permits because it gets that revenue.
