III. ACTION ITEMS

3.1 ASO/ICC Activities

Senator Jamie Holzer wishes to announce that in March she wants to do a Blue Ribbon event like the one we attended at the Leadership Conference at NLSC. Dr. Zimmerman explained to those present and did not attend the conference that the activity is designed to create a more appreciative, connection, active academic community and attitude—the point is to change the culture of the campus. Perhaps Troy could come in and train the leadership team, sponsored by ASO, and have students invite an instructor to the event.

Dr. Zimmerman expressed a conflict of March 20 to 23 to Washington, and March on March, on Monday, March 22 to Sacramento in March. If students wish to attend March on March, we will have to arrange a bus for that Sacramento trip; the conflict is the conference in Washington DC. We need to come up with a strategy to plan both events. Mandy needs enough time to plan transportation, and reservations to Washington. If we need to take a large group to Sacramento, we need to charter a bus; get a driver, and because of state law, we need two drivers, so they can rest. We can address this at the January retreat. I need to make arrangements, and get advisors to accompany the groups because I cannot do both. Trustee David Brown asked if he can drive himself to Sacramento; Dr. Zimmerman expressed that because it is an ASO event, students must travel together; independent travel is not allowed.

He encouraged everyone to utilize the discussion board in the ASO group to communicate during intersession.
