The total cost of the Washington DC trip is \$17,117.00. Vice President of Student Services Jonnmica Walter moved to allocate up to \$20,000 from the Student Representation Fee for this trip, Senator of Social and Behavioral Sciences, Business, Computer Studies and Economic Development, Enrique Camacho seconded the motion. Motion passed 9/0/0.

Vice President of Student Services Jonnmica Walter moved to allocate up to \$3,000 from the Student Representation Fee for the cost of the transportation and other costs for the March on March conference on April 22nd, 2010, Senator of Student Development and Services, Sandra Govin seconded, Motion passed 8/0/0.

ASO Advisor Dr. Jill Zimmermann addressed the group on details from the NCLS Conference in Atlanta, GA. She mentioned that the cost per person is \$509 plus the cost of airfare, meals and registration into the NCLS if booked before March 30. If students take the exam the costs is \$99 per person. Hotel cost is \$150 - \$175 (Double bed rooms) per person. The group decided that it will open the opportunity to clubs and people that are heavily involved in ICC to join ASO in this trip. The group also decided to limit the number of people going to 10 which will require approximately \$20,000. Among the clubs mentioned for consideration are ROTARACT, MUN, ASL, Alpha Iota, and the Psychology Club. Senator of Language Arts and Instructional Resources, Karole Obrikat moved to allocate up to \$20,000 for the NCLS Conference in Atlanta, GA for 10 people that are currently involved in ASO and ICC activities and are coming back next year. Vice President of Student Services Jonnmica Walter seconded the motion, Motion passed 8/0/0.
