3.2 Guest Speaker: Deputy Ruiz

- ❖ Deputy Ruiz was not at the meeting at the time we moved to 3.2. Vice President Sara Rothenberg moved to revisit 3.2 at 4:30 PM, Senator Shanoah Garcia seconded. Motion passed 13/0/0.

- ❖ Deputy Ruiz thanked us for having him. ASO officers brought up their concerns about the smoking policy, marijuana on campus, and about having an escort to their cars late at night.

- ❖ Deputy Ruiz explained that the handbook explains that this is one of their main goals and a student can call 722-6399 from their cell phone to get an escort to their car.

- ❖ He also explained that the smoking policy is indeed being enforced, however it is still new and they are trying to get better signs put up on campus. Next semester they will be stricter. Right now they are giving warnings, and then filing a report if the same person is still smoking on campus. There will be a track record and incident reports and that will be sent to the student court about students who do not obey the new policy. Another step is safety for smokers in the parking lots.

- ❖ As for marijuana, they have done arrests and the necessary discipline for this issue.

- ❖ The security guards are also cracking down on the misuse of handicap placards. Citations are being issued and filed for the abuse of placards. Deputy Ruiz ensured that this is being enforced. Handicap placards can also park in staff parking.

- ❖ Deputy Ruiz discussed lighting issues and security guards are more available in those areas.

- ❖ He also discussed that they are going to start bringing dogs on campus to enforce the misuse of marijuana on campus. The dogs will also be able to smell out weapons and other illegal drugs. There will be scheduled and surprise inspections.

- ❖ ASO officers expressed their concern about areas where sheriffs are not seen such as the library plaza and the fine arts quad. Deputy Ruiz took note of this.

- ❖ Tatiana Konovalov asked what the boundaries were for smoking. Deputy Ruiz said it depended where the parking lots are available right now due to construction. He also said there was no ticketing for smoking. There is ticketing for the STATE law, if someone is smoking less than 25 feet away, they will be ticketing.

- ❖ Deputy Ruiz explained that each color of the uniform is a different position. The white uniforms are security guards. The black uniforms are more like police officers. They all went through the same training, however.

- ❖ ASO officers thanked Deputy Ruiz for being here and Deputy Ruiz was happy to answer all questions and concerns.
