IV. ACTION ITEMS

4.1 ASO Committees and Appointments

Dr. Zimmerman reminded everyone that the Safety Committee needs a student representative.

Sandra Govin also stated that the Distance Education Committee is also looking for a student representative.

4.2 ASO/ICC Events

Sandra Govin gave a report about the ASO Hearts and Hands pantry's coat drive. She reported that between 50-60 coats have been dispersed already. Sandra stated that there are some coats still available and that they will be placed out in the pantry every Wednesday for the rest of the month of November. Sandra also reported that Rotoract and the Firefighters club on campus are collaborating to provide turkey dinners for 6-8 needy students and their families on campus. The firefighters club will be delivering these dinners to the families on Thanksgiving.

Moved to approve Movie Madness on November 30, 2011 from 12:00 P.M. through 2:00 P.M. in the Student Lounge with free pizza, popcorn, and soda provided for those

who attend, as well as 3 opportunity drawings for tickets to the Comedy Club at Bex on the BLVD and 2 tickets to the new movie theater on the BLVD with a budget up to \$300, by Edward Oquendo, seconded by PJ Delgaudio, Motion passed 6/0/0.

Sandra Govin stated that the Oil Tax Initiative has been extended for 150 days to allow for more signatures to be collected. They will also include now taxes on natural gas.

Terrance also spoke about a 3 on 3 basketball tournament and stated that he will check if we can hold the event in the Gym on campus. Dr. Zimmerman suggested that we look into this for the Spring Semester.

a. NCSL

b. General Assembly

Sandra Govin reported that the Statewide Student Senate (CCCCSS) is requesting that all ASOs send \$1000 from the Student Representative Fee to keep the Council going. She also reported that the Chancellor spoke to the council about "Community College is not for everyone". The Chancellor has requested that Lifelong learners not come to Community Colleges for a while because of the budget to allow for transfer students and those seeking degrees to be able to go through. Basic Skills are also facing changes at the state level.

Terrance reported that there are 3 Region wide committees still seeking students from Region 6. These committees are the Voter Registration, Advocacy Group, and Finances.
