II. PUBLIC FORUM

- A. Harmony Perkins says the Student Activities Council is setting up a Spring Fest Talent Show and they want people to show their talent. She is also inviting clubs to fundraise during the event. - B. Michelle Hernandez wants the ICC to discuss and decide on policies regarding fundraising off campus. She is trying to put up a policy figure for community donations

and fundraising events. She is also including sponsorship. Harmony said Dr. Zimmerman wants a list of community figures so she could contact them and see how they can work with the student clubs through the college.

### III. CLUB RELATED ITEMS

#### 3.1.1 ACTIVATIONS AND DEACTIVATIONS

There were two packets for activation. Student Advancement wants to reactivate their club. The deactivation was a mistake due to lack of communication. Second packet was for SNAC Spring 06.

Ma-Rodders moved to approve the reactivation of the Student Advancement Club and the activation of the SNAC Spring 06 club. Psychology seconds.

Discussion: Harmony mentions that there may be a stipulation regarding reactivation of clubs in mid-semester. Harmony Perkins took a personal privilege to retrieve an ICC Constitution. Michelle says that there will be a meeting for all Nursing Clubs to put the entire nursing club under one umbrella with possibly one person representing all the clubs. Harmony returned and stated on Article V of the ICC Constitution, Activation and Reactivations section two, the clubs must maintain 10 students for their club. Also clubs may reactivate with a two-thirds approval of the ICC and from ASO. Michelle says that clubs should request their own deactivations in writing with student and advisor signature. Doug says that the written correspondents were not correct because the advisor's and the president's signature were not present.

MA-Rodders amended their previous motion to approve SNAC Spring 06 to be activated and the reactivation of Student Advancement depending upon paperwork. Latino Club seconds.

Discussion: ASL asked what is meant by paperwork. The paperwork, signatures of the club's president and advisor. MA-Rodders amended their previous motion to just activate SNAC Spring 2006. Motion approved 17/0/0.

Motion to approve reactivation of Student Advancement pending paperwork and activate SNAC Spring 2006 by MA-Rodders, seconded by Latino Club. Motion failed 0/16/01.

The original motion on the table to reactivate Student Advancement and activate SNAC Spring 2006 by MA-Rodders, seconded by Psychology, motion failed 0/17/0.

ASL moved that the deactivation of Student Advancement and Physics and Engineering be voided due to incomplete paperwork. The Alliance seconds.

Discussion: AVC Psychology stated it would be wise to see the paperwork before taking the vote. Motion approved 15/0/2

Outcome SNAC spring 2006 was approved and the deactivates were voided.
