Description: CRN 74643, 35075, 35076, 35081, 74638 needs to be relocated in the FA3/FA4 (Fine Arts area) section of campus. APL 111 has limited seating and is a computer lab for our music production courses. Having non-music production lecture courses in the lab presents a danger to the equipment

being stolen or damaged. In the past we have had equipment stolen and not replaced by the college. In addition the seating in the computer is limited to 22 tables. These tables have computers, monitors, music keyboards, and other pieces of equipment on the tables, making them unusable for taking lecture notes as in a traditional lecture class. CRN 74638 has an enrollment of 35 students with 22 tables that are not usable for taking notes, and the remaining students have to take notes on their laps. Finally, the History of Jazz & History of Rock'n Roll involves playing music and the adjoining rooms complain about the music. If the course is located in an area such as Fine Arts it is to be expected but when you have music coming from an area next to math, english, and engineering courses it can cause a disturbance.
